CALL TO ORDER

The Oklahoma Conservation Commission met Monday, December 3, 2018, in the Agriculture Building Conference Room located at 2800 N. Lincoln in Oklahoma City, Oklahoma. The meeting was called to order at 9:30 a.m. by Chair Bill Clark. He stated this was a regular scheduled meeting held in accordance with the Open Meeting Law, Title 25, Oklahoma Statutes, Sections 301 and following as amended. The agenda for this meeting was posted at 1:00 p.m. Thursday, November 29, 2018, at the front entrance of the Oklahoma Agriculture Building.

MINUTES OF PREVIOUS REGULAR MEETING

A motion was made by Mrs. LeGrand and seconded by Mr. Herriman to approve the minutes of the November 5, 2018 Commission meeting as written. Those voting aye were: Jett, Clark, Herriman and LeGrand. Nay votes: none. Motion carried.

CLAIMS/FINANCIAL STATEMENT

Trey Lam, Executive Director, presented the claims, purchase card summary and financial statement as listed in Exhibit #1. RECOGNITION OF COMMISSION EMPLOYEE

Mr. Toole, AML Division Director, presented Trampas Tripp with an award for 10 years of service at the Oklahoma Conservation Commission. He stated that Mr. Tripp began his career with the agency as a conservation plan writer before moving to become an AML inspector and ultimately the project inspector he is today.

PRESENTATION OF AGREEMENTS

Ms. Lam presented one new agreement listed as item "a" in Exhibit 2, for possible approval. The agreement is the AML Reclamation annual grant request to the United States Department of Interior Office of Surface Mining. He recommends approval of this agreement as presented. CONSERVATION PARTNERSHIP REPORTS

Oklahoma Department of Agriculture, Food and Forestry: Betty Thompson, Department of Agriculture Deputy Commissioner, reported on the following items: The Department is in a transitional phase with the turnover in leadership and the new legislature. Ms. Thompson reported that there is urgency for an agricultural voice at the capital right now.

Natural Resources Conservation Service: Gary O'Neill, State Conservationist, reported on the following items:

- December 19th is the EQIP program cutoff.
- Congress has reached an agreement on the Farm Bill.
- CSP will remain a standalone program.
- There will be training for new district conservationists on January 15-17th of next year.
- NRCS will host the OACD leadership class in Stillwater, OK on January 23-24th, 2019.
- The Cherokee Nation has established a conservation district and will have some shared positions with NRCS.

Oklahoma Association of Conservation Districts: There was nobody in attendance to give an update.

OKLAHOMA CONSERVATION COMMISSION MEMBERS

Mr. Jett reported that they are setting up a food bank in Cimarron County. He also stated that he attend an informative irrigation meeting in the panhandle.

Mr. Campbell was not in attendance.

Mr. Herriman stated that he had nothing new to report.

Mrs. LeGrand reported that she believed her area meeting went well, and was pleased with the attendance this year.

Mr. Clark stated he attended his area meeting in Idabel, OK. He stated that turnout was relatively low for Area 5.

OKLAHOMA CONSERVATION COMMISSION STAFF

Executive Director: Mr. Lam stated a written report is in the packet. Mr. Lam reported on the following items:

- With the exception of Area 5, attendance was good for this year's Area Meetings.
- He participated in a poultry meeting with the Secretary of Agriculture and Secretary of Energy and Environment.
- Attended a meeting in Guymon with the Oklahoma Department of Agriculture to discuss plans to start an Irrigation District.
- Bond is advancing and will be issued in April, 2019.

Water Quality Program: Mrs. Phillips reported on the following items:

- She and Greg Kloxin attended the 2018 National Nonpoint Source Training Workshop in Colorado Springs.
- Mr. Kloxin made a partnership presentation to NRCS. They were subsequently invited to Wyoming next year.
- Judith Wilkins retired at the end of November. There are currently plans to replace her in early 2019.

Office of Geographic Information and Technical Services: Mike Sharp, Director, stated a written report is in the packet. He noted that OK Maps usage continues to be expanding.

Abandoned Mine Land Reclamation Program: Robert Toole, Abandoned Mine Lands Reclamation Program Director, stated that a written report was in the Commissioner's packet. Mr. Toole summarized the report stating that construction was on-going on one project in Rogers County. Two projects have been advertised for bids with one receiving an acceptable bid of just over \$1 million. The second project will open bids later in December. Questions and discussion ensued about the impacts to the AML Program resulting from the American Burying Beetle and other environmental restrictions.

Conservation Programs: Tammy Sawatzky, Director stated that a written report was in the packet. Ms. Sawatzky reported the following items:

- There was a lot of interest at the site showing for the Cottonwood 54 rehabilitation project with eight (8) contractors in attendance. Plans are to have the bid awarded in late December with

construction underway in February, 2019.
