The Oklahoma Conservation Commission met Monday, April 2, 2018, at the Agriculture Building Conference Room located at 2800 N. Lincoln in Oklahoma City, Oklahoma. The meeting was called to order at 9:30 a.m. by Chair Deanna LeGrand. She stated this was a regular scheduled meeting held in accordance with the Open Meeting Law, Title 25, Oklahoma Statutes, Sections 301 and following as amended. Shanon Phillips, Water Quality Division Director presented Candice Miller, Water Quality Blue Thumb Educator for recognition of 5 years of service.

Lisa Knauf Owen, Assistant Director presented an amended agreement listed as item "a" in Exhibit #2. She recommended approval of this agreement as presented. ALLOCATION OF FUNDS TO LITTLE RIVER CONSERVATION DISTRICT FOR COST-SHARE PROGRAM YEAR 19

Tammy Sawatzky, Conservation Programs Director, presented Commissioners with an email request (Exhibit#5) from Little River Conservation District asking to participate in Program Year 19 Cost-Share program. Ms. Sawatzky indicated that the district has chosen not to participate in the past two cost-share programs. She also noted that applying the formula that she used to determine all district allocations for this year's program she would recommend an allocation of \$8,452.00. After discussion, a motion was made by Mr. Clark and seconded by Mr. Jett to approve a cost-share allocation to Little River Conservation District in the amount of \$8,452.00 for Cost-Share Program Year 19. Those voting aye were: Jett, Campbell, Herriman, LeGrand and Clark. Nay votes: none. Motion carried.

CONSERVATION PARTNERSHIP REPORTS

Oklahoma Department of Agriculture, Food and Forestry: Betty Thompson, Deputy Commissioner reported on the following items:

- -The House and Senate have agreed to and passed a revenue bill that has been signed by the Governor with a repeal of the hotel/motel tax.
- -Ag Day at the Capitol is scheduled for April 10 with presentations to the Hall of Fame winners.
- -The Ferguson Family Dairy is opening this week on the Oklahoma State University campus.
- -Continuing to work with Legal and the Department of Public Safety to clean up language so as not to conflict with federal law regarding Electronic Logging Device rules.
- *USDA-Natural Resources Conservation Service:* Gary O'Neill, State Conservationist reported on the following items:
- -Had successful legislative visits during the NACD Spring Fly-In. Had opportunity to meet with the newly appointed Undersecretary, Bill Northey.
- -NRCS in Washington D. C. has approved the state restructure plan. A memo will go out to the field this week to begin establishing the teams.
- -The Agency is offering state CIG grants of up to \$75,000 for a total of \$300,000 and will also be offering Technical Assistance grant opportunities to groups, entities and organizations.
- -There have been several employee changes this past month: Retirements Tony Schreiner, Technician; Mike Till, Technician; Birdie Neil, State Office. Transfers Wynea Bufford, District Conservationist; Joe Bufford, State Office; and Josh McNeff, Technician Resignations Andy Lowman, Technician.
- -Had a great day shooting video out at Jimmy and Ginger Emmons Farm for the Leopold Award.
 - -The SAMS/DUNS issue has been addressed in the omnibus bill.
- Oklahoma Association of Conservation Districts: Jimmy Emmons, President reported on the following items:
- -Due to cancelation of flights, Mr. Emmons noted he was able to participate in the National Watershed Coalition legislative visits during following the NACD Spring Fly-In.
- -Working with Congressman Lucas on sponsorship of a bill to assist beginning farmers implementing good farming practices.
- -Continuing to work on the issue of cover crop termination dates to clarify terminology between RMA, FSA and NRCS. Most of these issues have been addressed in the current draft of the new Farm Bill.
- -Spoke with Josh Maxwell, Chief of Staff for Congressman Conway, to discuss concerns with changes to CSP/EQIP. He agreed to work with OACD on correspondence to send out to districts.
 - -There is currently \$100,000,000 of funding in the new Farm Bill to be split between

NRCS and APHIS for feral hog work.

- -The first session of the Leadership Class is scheduled for this week.
- -Conservation Day at the Capitol is scheduled for April 12th with districts meeting at the Commission for a briefing at 8 a.m. and awards at 10 a.m. in the Capitol Blue Room.
 - -National Land Judging will be coming up in early May.

OKLAHOMA CONSERVATION COMMISSION MEMBERS

Mr. Campbell thanked Mr. O'Neill for inviting him to participate in the national State Conservationist meeting held in Oklahoma to discuss his perspectives as a producer. He also noted he attended an Ag Day at Langston University and had opportunity to visit with the University President. Mr. Campbell reported that he attended GIS Day at the Capitol.

Mr. Jett reported that he has been working on some challenging issues at his local district office.

Mr. Clark reported that he had attended the NACD Spring Fly-In in Washington D.C. He also stated that the Pontotoc County Conservation District Watershed Aid, Bobby Hatton, had passed away over the weekend after a short battle with brain cancer. He noted that the local district hosted their land judging contest.

Mr. Herriman reported that the Nowata County Conservation District is now sharing staff with Caney Valley Conservation District and its working. He also noted that the local district had hosted their land judging contest. Mr. Herriman reported on his attendance at the NACD Spring Fly-In.

Ms. LeGrand reported that she had participated in a joint meeting between the Custer County and Deer Creek Conservation District boards.

OKLAHOMA CONSERVATION COMMISSION STAFF

Executive Director: Mr. Lam stated a complete written report is in the packet. Mr. Lam reported on the following items:

- Participated as member of panel discussion during the NRCS all State Conservationist meeting held in Norman, OK.
 - Attended Kay County Conservation District annual banquet.
 - Attended watershed banquets in Murray and Noble County Conservation Districts. Ms. Sawatzky did an excellent job in her presentation about the watershed program.
 - Participated in interviews for the Commission Soil Health Coordinator position and is pleased to announce that Amy Seiger has accepted the position.
 - Attended the Johnston Seed 125th Anniversary celebration in Enid, OK.
 - Participated in the NACD Spring Fly-In to Washington, D.C. Most of the visits entailed educating congressional staff.
 - Met with Congressman Mullin at the Muskogee County Conservation District to discuss upstream flood control in his area.
 - Attended a special meeting of the Deer Creek and Custer County Conservation Districts.

Water Quality Program: Shanon Phillips, Director, stated a written report is in the packet. Ms. Phillips reported on the following items:

- Introduced Amy Seiger as the new Soil Health Coordinator. The position is a partnership with NRCS, The Nature Conservancy and OCC Water Quality with funding through EPA. One of the main responsibilities of the Soil Health Coordinator will be to reach out to all partners to coordinate efforts in Soil Health.

- -A new Blue Thumb staffer has been hired. Becky Zawalski will start work next week.
- -State Revolving Fund projects update: Raingardens with GRDA will be out to bid soon; Wetland creation in Eufaula has had one payment processed and work continues; pervious parking area at Lake McMurtry is complete.

Office of Geographic Information and Technical Services: Mike Sharp, Director, stated a written report is in the packet. Dr. Sharp stated that we held another successful GIS Day at the Capitol and congratulated Shellie Willoughby on a job well done. He noted that OkMaps plans to exhibit during Conservation Day at the Capitol. Dr. Sharp also reported that he has been working with Oklahoma Highway Patrol to develop maps for the April 2nd Teacher Walkout and Rally.

Abandoned Mine Land Reclamation Program: Robert Toole, Abandoned Mine Lands Reclamation Program Director, stated that a written report was in the Commissioner's packet. Mr. Toole summarized the report stating that: construction was completed on one (1) project; construction is on-going on two (2) projects; construction is pending on four (4) projects; vegetation being managed on four (4) projects; four (4) projects are being monitored for maintenance; three (3) projects are in the design phase; two (2) projects are in survey phase; three (3) sites are in realty phase; six (6) sites are holding for project selection. Toole also reported that Oklahoma AML received their Annual Evaluation Report from the Office of Surface Mining Reclamation and Enforcement (OSMRE). OSMRE reported that, "OCC's reclamation of AML emergencies and routine AML projects has resulted in the successful implementation of the AML program."

Conservation Programs: Tammy Sawatzky, Director, stated a written report is in the packet. Ms. Sawatzky reported on the following items:

- -Watershed Technicians and District Watershed Aides are assisting Muskogee County, Logan County, Arbuckle and Konawa Conservation Districts with watershed inspections.
- Rehabilitation construction is beginning to day on Rock Creek Site 15. Due to the recent rains the construction company will be drawing down water in order to begin.
- -Surveyors will be onsite at Cottonwood Creek Site 54 to begin staking the work limits. Janet Stewart, OCC General Counsel has contacted the landowners.
- -Janet Stewart is attending the Oklahoma Water Resources Board Hazard Classification hearing for Sallisaw Site 33 today for a final determination.

Assistant Director: Ms. Owen noted that monthly activities are outlined in the written report. Ms. Owen reported on the following items:

- -Assisted Logan County Conservation District with board meeting and day to day operations.
- -Assisted Beaver County Conservation District with an in-depth review of district finances.
- -Sent reminder notice to conservation districts regarding Notice of Filing period requirements.
- -Prepared quarterly accruals for NRCS agreements. Prepared billings for NRCS agreements.
- -Prepared and provided data to OMES for bid packet on Workers Compensation for the Commission and Conservation Districts.

Oklahoma Statutes Citationized

Title 74. State Government

Chapter 56 - State Employment Review Board

ESection 3601.2 - Salaries of Chief Executive Officers

Cite as: 74 O.S. § 3601.2 (OSCN 2018)

A. Beginning July 1, 2013, each agency, board, commission, department or program in the executive branch of state government shall establish the salary of each of the chief executive officers for which they have appointing authority. Such salary shall be set between the minimum and maximum of the range specified in the annual compensation reports required by paragraph 5 of Section 840-1.6A of this title, for full-time employees only.

B. All increases require certification of the appointing authority that said action can be implemented for the current fiscal year and subsequent fiscal year without the need for additional funding. The agency, board, commission, department or program shall report increases granted under this section to the Office of Management and Enterprise Services on an annual basis by August 1 of each year. The Office of Management and Enterprise Services shall forward a report of such increases to the Governor, President Pro Tempore of the Senate, and Speaker of the House of Representatives no later than September 1 of each year.

C. Every three (3) years beginning with fiscal year 2013, the Office of Management and Enterprise Services shall review these salary ranges and report on and make recommendations on proposed salary ranges in its annual compensation reports mandated by paragraph 5 of Section 840-1.6A of this title. Such recommendations shall be made no later than February 1 for chief executive officers in all state agencies, boards, commissions, departments or programs in the executive branch of state government, including but not limited to those specified in Section 3601.1 of this title.

MERIT SYSTEM OF PERSONNEL ADMINISTRATION RULES

Effective as of 9/01/2017

260:25-7-2. Salary schedule

The rate of pay of employees shall be maintained within pay band structures established by the Human Capital Management Division of the Office of Management and Enterprise Services [74:840-4.6] for the job family level and kept within the established minimum and maximum rates of pay, except as provided by law or Merit Rule.

Conservation Commission Executive Director Salary Recommendation - 2018

OMES, Human Capital Management Division (HCM) annually reviews salaries of state employees and agency directors. The 2017 Annual Compensation Report contains the latest figures on compensation, turnover cost, and employee benefits (see attached).

Director Lam's current salary is \$70,500 annually. As shown below, his compensation is 39% below the midpoint.

(1) Compa-ratio is calculated as the employee's current salary divided by the midpoint rate. Each position has a salary range that includes a minimum, a midpoint, and a maximum. These three values represent market averages for the position. A Compa-Ratio of 100% means that the employee is paid exactly what the market average pays and is at the midpoint of the salary range.

Comparisons

Comparing agency director's salaries, Conservation Commission has the lowest Compa-Ratio of any agency director. Executive Director Lam's compensation is 39% below the Midpoint. For a comparison how directors align with the salary structure, see the chart below.

Salary Compression

Normal salary spacing between jobs should be 10% to 20%. When normal spacing is absent, salary compression occurs. Salary compression is so severe within Conservation Commission that five (5) employees earn within \$91 of Director Lam's salary.

The Legislature passed HB1024XX which provides employee pay increases and excludes agency directors. State employees will receive pay increases varying from \$2,000 to \$750. Five Conservation Commission employees will earn more than Director Lam on July 1, 2018 unless an adjustment is made to the Executive Directors salary.

Recommendation

Based on the available information, the Conservation Commission Executive Director salary should be a minimum of \$91,573. Due to increasing wage growth, setting compensation at this level would require annual review and adjustments. The most recent adjustment to the director's pay scale was 5% for 2018. To avoid annual adjustments, the Directors salary could be set at the midpoint or at some point to above the minimum.

The ideal compensation level for the Conservation Commission Executive Director salary is \$114,466.
