The Oklahoma Conservation Commission met Monday, July 1, 2019, in the Agriculture Building Conference Room located at 2800 N. Lincoln in Oklahoma City, Oklahoma. The meeting was called to order at 9:30 a.m. by Chair Karl Jett. He stated this was a regular scheduled meeting held in accordance with the Open Meeting Law, Title 25, Oklahoma Statutes, Sections 301 and following as amended. The agenda for this meeting was posted at 1:00 p.m. Thursday, June 27, 2019, at the front entrance of the Oklahoma Agriculture Building.

Nancy Tackett, Comptroller, presented the claims, purchase card summary and financial statement as listed in Exhibit #1. A motion was made by Mr. Campbell and seconded by Mr. Clark to approve the claims and financial statement. Those voting aye were: Jett, Campbell, Herriman, Forst, and Clark. Nay votes: none. DISCUSSION AND POSSIBLE APPROVAL TO DECLARE THE CANDIDATES IN DISTRICTS WHERE ONLY ONE ELIGIBLE PERSON FILED A NOTIFICATION AND DECLARATION OF CANDIDACY AS ELECTED TO POSITION #3

Mrs. Owen noted that due to circumstances beyond OCC's control some districts had to hold special filing periods and/or elections. Mrs. Owen presented the list of eligible individuals filing a Notification and Declaration of Candidacy for Elected Position #3 as listed in Exhibit #5. She recommended that the positions be declared "elected". A motion was made by Mr. Clark and seconded by Mr. Campbell to declare the positions elected. Those voting aye were: Jett, Campbell, Herriman, Forst, and Clark. Nay votes: none. Motion carried.

REVIEW OF WAGONER COUNTY CONSERVATION DISTRICT SPECIAL ELECTION WHERE MORE THAN ONE CANDIDATE FILED FOR ELECTED POSITION #3 (EXHIBIT #7)

Mrs. Owen discussed with Commissioners the circumstances requiring the special election in Wagoner County and noted the election would be held July 23, 2019. No action was required to be taken.

Mrs. Owen reviewed and recommended approval of the conservation district allocations for personnel and operating expenses as listed in Exhibit #11. She also noted the allocations include funds for new positions, special projects, operating expenses, and the state employee pay raise. A motion was made by Mr. Campbell and seconded by Mr. Forst to approve the allocations

as presented. Those voting aye were: Jett, Campbell, Herriman, Forst, and Clark. Nay votes: none. Motion carried.

Mr. Lam reviewed and recommended for approval the Agency Budget Work Program as presented in Exhibit #12. A motion was made by Mr. Clark and seconded by Mr. Campbell to approve the program as presented. Those voting aye were: Jett, Campbell, Herriman, Forst, and Clark. Nay votes: none. Motion carried.

Mr. Lam discussed the conservation district director meeting expense, noting it could not exceed \$25.00/meeting with a maximum of 12 meetings and would be reimbursed to the districts from their standard operating allocation. A motion was made by Mr. Clark to set the meeting expense at \$25.00/meeting with a maximum of 12 meetings; Mr. Campbell seconded the motion. DISCUSSION AND POSSIBLE RATIFICATION OF THE FOLLOWING DECLARATION OF ABANDONED COAL MINE EMERGENCY

Robert Toole, Abandoned Mine Land Division Director, led a brief discussion of the Lindsay, OK 2019-03-03 emergency. He stated there was a mine collapse a few feet from the backdoor of a family home in Wilburton, Oklahoma. Mr. Toole would recommend ratification of the emergency declaration as presented in Exhibit #13. A motion was made by Mr. Herriman and seconded by Mr. Clark to ratify the declaration as presented. Those voting aye were: Jett, Campbell, Herriman, Forst, and Clark. Nay votes: none. Motion carried.

CONSERVATION PARTNERSHIP REPORTS

Oklahoma Department of Agriculture, Food and Forestry: JanLee Rowlett, ODAFF Legislative Liaison, reported on the following issues:

- -MASDA Conference was held in Oklahoma City June 23 June 26.
- -USDA Under Secretary, Bill Northey, toured flood damage around the state.

Natural Resources Conservation Service: Gary O'Neill, NRCS State Conservationist for Oklahoma, stated a copy of the Conservation Partnership report is in the packet and reported on the following items:

- Flood damage to 35 EWP sites has been estimated at \$5,000,000.
- EQIP signup for counties identified as flood damaged will run through July 12, 2019; the signup will focus on cover crops with a hay/graze option.
- CSP Grassland Conservation Initiative signup has been extended to July 19, 2019; GCI provides producers a one time signup for a five year contract to address grass planted base acres.
- CSP rankings are being completed.
- Working through watershed operation and maintenance funding requests.
- 15 participants completed the basic conservation planner class, additional classes will

follow.

- 6 intern/student employees will be converting to full-time employees.
- Jamey Wood will be relocating to Fort Worth, TX to become part of the Workforce Planning Division.

Oklahoma Association of Conservation Districts: Larry Wright, OACD President, gave the following update:

- Ms. Sara Blaney is assisting Conservation Districts in completing applications for the USDA urban conservation grants.
- OACD is finalizing plans for hosting the NACD South Central Meeting in Thackerville, Oklahoma on July 21-23rd, 2019.
 - A Spanish language marketing piece has been completed.
 - Collaborating with OCC for an application for a Conservation Innovation Grant.
- Pleased to see Oklahoma moving towards more shared positions, particularly those of certified planners.

OKLAHOMA CONSERVATION COMMISSION MEMBERS

Mr. Jett stated that the weather is improving, but turning hot.

Mr. Campbell stated that Oklahoma County CD is planning a Cedar & Pasture Field Day and that his grandkids are visiting the farm this summer; he is teaching them the importance of hard work.

Mr. Herriman stated that he had visited the flood areas around Fort Gibson and Sallisaw; he thanked Bryan Painter for coordinating the visit and is buoyed by the amount of help available to those affected by the floods. He also stated that due to silt deposits from the flooding on his farm, he was unable to No-Till and had to use a cultivator for the first time in years.

Mr. Forst introduced himself and explained the hunting component of his ranch operations; he noted that hunting of feral hogs is especially popular.

Mr. Clark stated five counties in his Area are planning a Soil Health seminar with a grazing focus for September 5, 2019.

OKLAHOMA CONSERVATION COMMISSION STAFF

Executive Director: Mr. Lam stated a written report is in the packet. Mr. Lam reported on the following items:

- Representative Markwayne Mullin visited the office to discuss flooding concerns in his district.
- Mr. Lam toured flood damaged areas with Oklahoma Secretary of Agriculture, Blayne Arthur, and USDA Under Secretary, Bill Northey.
- Mr. Lam noted that Blue Thumb had organized a water well testing event for those in flood affected areas.
 - Mr. Lam also noted that the staff had been busy with budget work.

Water Quality Program: Mrs. Phillips stated a written report is in the packet. Mrs. Phillips reported on the following items:

- Pleased with the effort put in by the Blue Thumb staff to quickly organize the well testing

event Mr. Lam mentioned.

- Mrs. Phillips stated that the division is working with OACD on the Conservation Innovation Grant proposal.
 - She and Greg Kloxin met with OWRB regarding the nonpoint source management plan.
 - The Water Quality team is working with Scissortail Park on possible education events.

Office of Geographic Information and Technical Services: Mike Sharp, Director, stated a written report is in the packet. Mr. Sharp also reported the following:

- Working on a plan to replace/consolidate IT infrastructure; has received some additional funding from the Department of Homeland Security to replace some network components.

Abandoned Mine Land Reclamation Program: Robert Toole, Abandoned Mine Lands Reclamation Program Director, stated that a written report was in the Commissioner's packet. Mr. Toole summarized the report stating that: June could best be characterized by the Bacon AML Maintenance Project that has not yet commenced work but we are on our third contract extension due to weather days. Not only has construction been delayed but vegetative work has been delayed as well. In addition to the one emergency remediated in June, three projects continue in construction; five projects are in vegetation management and monitoring; six projects are in design; two projects are in realty phase; four projects are being solicited for American Burying Beetle surveys to complete environmental clearances.

Conservation Programs: Tammy Sawatzky, Director stated that a written report was in the packet. Mrs. Sawatzky reported the following items:

- She is preparing to order new equipment for use in the field.
- She has been working with the North Fork of Red River Conservation District on Upper Elk Creek 23D land rights.
 - She has been working with the City of Perry on the rehab match.

Assistant Director: Lisa Knauf Owen reported on the following items:

- Iris Imler will be retiring from the Cimarron County Conservation District on July 31, 2019. Mrs. Imler has been with the CCCD for over 30 years.
- Hal Clark, former Cimarron County Conservation District Director and OCC Commissioner, is recovering from a broken hip.
 - Erin Ely, Administrative Programs Officer, began maternity leave on June 27, 2019.
- Owen, Sawatzky, Ely, and Green attended a two day administrative investigation course taught by OMES.
- Mrs. Owen noted she has been busy with the OCC budget and preparing POs and RFAs for the new FY as well as with agreement budgets.
 - Mrs. Owen reminded the Commissioners to check their ok.gov email addresses.

FISCAL YEAR 20 - PROPOSED DISTRICT POLICIES

- 1. All employee positions (District and Commission) that become vacant will be reviewed and will require justification before approval to fill the position. Future employee allocations will be dependent on the level of legislative appropriations.
- 2. The maximum number of hours for a non-benefitted temporary district employee will be 1599 hours. However, if the employee works more than 999 hours, the district will be responsible for the employer's share of retirement contributions.
- 3. Districts were required to have long range plans approved by Commission staff prior to June 30th, 2019. Any district not receiving approval by the deadline will be given a provisional funding allocation. If final Commission approval is not received by September 1, 2019 the allocation will be reviewed and potentially reduced. The reduction may result in loss of staff.
- 4. Failure to perform audits and/or submit preclaim payments (for retirement and insurance) within the established timeframe will result in OCC withholding payment of district claims until compliance is accomplished.
- 5. In order for a district to be eligible to continue receiving a personnel allocation from OCC; the districts must perform annual performance evaluations on all staff.

Reasons for Emergency Declaration:

This project addresses the sudden collapse of an abandoned coal mine creating an dangerous vertical opening. The current approximate dimensions are 1 feet diameter on the surface then belled out to 6 feet diameter by 7 feet deep under the surface.

The site is located in a residential area of Wilburton, Oklahoma, in the backyard of a family home. The overburden has fallen straight down into what appears to be an abandoned mine room or entry. There is a high probability of substantial harm to the family and visitors.

The site is located at 141 Yellow Brick Road, Wilburton, Oklahoma. The vertical opening is in the back yard approximately 20 feet northwest of the back door. The Legal description is the NE SE of Section 9, Township 5 North, Range 19 East in Latimer County (Wilburton USGS Quadrangle), Oklahoma. The geographic coordinates are: 34.91571, -95.29753.

AML Project Management

Lindsey Emergency (Latimer County)

The project was declared an emergency by the Conservation Commission on June 5, 2019. This project addresses the sudden collapse of an abandoned coal mine creating a dangerous vertical opening. The current approximate dimensions are 1 feet diameter on the surface then belled out to 6 feet diameter by 7 feet deep under the surface. The site is located in a residential area of Wilburton, Oklahoma, in the backyard of a family home. Site is currently being reclaimed for an estimated \$8,750.

Moore North (Rogers County)

Reclamation construction completed. Vegetation is in progress.

Construction contract was awarded to Stewart Excavation, LLC, for \$1,020,855. The Notice to Proceed date is January 8, 2019. The contract time is 504 calendar days with a completion date of May 25, 2020. Construction is proceeding on schedule.
