i. Kiowa County Conservation District (OCC-553) to provide funds for a full-time Watershed Aide with the majority of time dedicated to O&M program duties. The work area for this agreement is all of Kiowa and Washita County Conservation Districts; with the aide headquartered in Kiowa County Conservation District.

j. Murray County Conservation District (OCC-554) to provide funds for a full-time Watershed Aide with the majority of time dedicated to O&M program duties. The work area for this agreement is all of Murray County and Arbuckle Conservation Districts; with the aide headquartered in Murray County Conservation District.

k. Noble County Conservation District (OCC-555) to provide funds for a full-time Watershed Aide with the majority of time dedicated to O&M program duties. The work area for this agreement is all of Noble, Pawnee, Garfield and Payne County Conservation Districts; with the aide headquartered in Noble County Conservation District.

l. Okfuskee County Conservation District (OCC-556) to provide funds for a full-time Watershed Aide with the majority of time dedicated to O&M program duties. The work area for this agreement is all of Okfuskee, Hughes and Seminole County Conservation Districts; with the aide headquartered in Okfuskee County Conservation District.

m. Pontotoc County Conservation District (OCC-557) to provide funds for a full-time Watershed Aide with the majority of time dedicated to O&M program duties. The Oklahoma Conservation Commission met Monday, June 4, 2018, at the Agriculture Building Conference Room located at 2800 N. Lincoln in Oklahoma City, Oklahoma. The meeting was called to order at 9:30 a.m. by Chairman Deanna LeGrand. She stated this was a regular scheduled meeting held in accordance with the Open Meeting Law, Title 25, Oklahoma Statutes, Sections 301 and following as amended. The agenda for this meeting was posted at 4:00 p.m. Tuesday, May 29, 2018, at the front entrance of the building.

CLAIMS/FINANCIAL STATEMENT

Nancy Tackett, Oklahoma Department of Agriculture Comptroller, presented the claims, purchase card summary and financial statement as listed in Exhibit #1. No specific information has been provided by the Texas Association of Conservation Districts. This will be placed on the agenda next month for action. No action needed.

DISTRICT DIRECTOR ELECTIONS FOR POSITION #2

Ms. Owen presented the list of eligible individuals filing a Notification and Declaration of Candidacy for Elected Position #2. She noted that there were no districts where more than one candidate filed. After discussion, a motion was made by Mr. Campbell and seconded by Mr. Jett to declare these individuals elected with a term beginning July 1, 2018. Those voting aye were: Jett, Clark, Campbell, Herriman and LeGrand. Nay votes: none. Motion carried.

FY 2019 APPROPRIATION AND BUDGET

Mr. Lam reported that the Governor has signed the Fiscal Year 19 budget which includes a 0.71% increase for the Conservation Commission. Included in the budget this year is a \$5.116 million bond issue for watershed rehabilitation and a pay raise for state and district employees. Mr. Lam noted that staff is currently working on preparing the budget and district allocations for approval at the July Commission meeting. No action needed.

CONSERVATION PARTNERSHIP REPORTS

Oklahoma Department of Agriculture, Food and Forestry: Betty Thompson, Department of Agriculture Deputy Commissioner, reported on the following items:

- Staff has finalized rules for industrial hemp. Langston University, Connors State College and Redlands Community College have all applied for industrial hemp study grants.
- Newly appointed Agriculture Commissioner Joe Mayer passed away.
- Secretary Reese will be presiding over the NASDA Conference in South Dakota.
- Mark Goeller has been appointed State Forester.
- The Legislature plans to adjourn on May 4, 2018.

Oklahoma Association of Conservation Districts: Larry Wright, President Elect reported on the following items:

- Seven marketing pieces have been completed for the 501 Project on small farms / disadvantaged farmers.
- There have been 13 Farm to Food Bank sites established. Each has received seed and the first gleaning is planned in Chickasha.
- Dates for the next sessions of the Leadership Class have been set: July 24-25 in Ardmore sponsored by the Noble Foundation to learn more about soil health and communications; September 17 – 18 in Tahlequah sponsored by the Cherokee Nation to learn about water quality issues.
- Demonstration Farms have been planted in Dewey, Greer and Pottawatomie Counties for the RCPP project. Craig County demo farm should be planted by June 15. Field Days are currently being scheduled.
- Distributing milk weed plants provided by Oklahoma Monarch Watch.
- National Land and Range Judging Contest concluded with 33 states represented and over

1000 students in attendance.

OKLAHOMA CONSERVATION COMMISSION MEMBERS

Mr. Campbell reported that he attended the Small Farms Conference at Langston University.

Mr. Jett reported on attending the Texas County Conservation District board meeting. He also noted he is assisting Clay Pope with scheduling drought and prescribed fire meetings in the panhandle.

Mr. Clark reported that he attended a 3 day Soil Health Seminar in Shawnee.

Mr. Herriman stated that the Nowata County Conservation District pickup had been stolen from the parking lot and ultimately recovered on the Turnpike. No report yet on the damage.

Ms. LeGrand stated she had nothing to report this month.

OKLAHOMA CONSERVATION COMMISSION STAFF

Executive Director: Mr. Lam stated a written report is in the packet. Mr. Lam reported on the following items:

- Attended the Legislative Stewardship Breakfast hosted by Wagoner County Conservation District.
- Attended the Alfalfa County Conservation District board meeting.
- Met with Representative Kevin Wallace, Town of Meeker, NRCS and agency staff to discuss the potential for rehabilitation of Meeker Lake.
- Volunteered at the Oklahoma City Food Bank as part of Employee Recognition Week.
- Attended the Small Farmers Conference hosted by Langston University.
- Met with the Dean and Professors from Langston University to discuss soil health practices on a 40 acre test plot.
- Hosted the agency Full Staff Meeting.

Water Quality Program: Shanon Phillips, Director stated a written report was in the packet. Ms. Phillips reported on the following items:

- Staff participated in field days hosted by Creek and Harmon County Conservation Districts.
- A contractor has been selected to construct the bio retention cells at Grand Lake as part of the OWRB SRF project.
- Plans are moving forward with the wetland project on Lake Eufaula.
- Greg Kloxin was at the Noble Research Foundation to discuss what makes a successful water quality conservation program. He discussed the importance of monitoring and data collection to show success.

Office of Geographic Information and Technical Services: Mike Sharp, Director, stated a written report is in the packet. He noted that this was a fairly routine month for the division.

Abandoned Mine Land Reclamation Program: Robert Toole, Abandoned Mine Lands Reclamation Program Director, stated that a written report was in the Commissioner's packet. Mr.

Toole summarized the report stating that: construction is on-going on one (1) project; seven (7) projects are pending environmental clearances; vegetation management is being performed on four (4) projects; two (2) projects are being monitored for maintenance; two (2) projects are pending right-of-entry; seven (7) sites are on hold pending project selection. Mr. Toole also noted the cooperative project involving the Cherokee Nation, private landowners, Muskogee County Conservation District, the Office of Surface Mining Reclamation and Enforcement (OSMRE) and Oklahoma AML Program.

Conservation Programs: Ms. Owen noted that Tammy Sawatzky was on leave this week. She stated a written report is in the packet. Ms. Owen reported on the following items:

- Bid solicitation for the Sugar Creek remedial project has been prepared.
- A pre-bid meeting was held on Cottonwood Site 54 Rehabilitation project on May 22 with approximately 10 construction firms represented.

Assistant Director: Ms. Owen noted that monthly activities are outlined in the written report. Ms. Owen reported on the following items:

- Continues to assist Logan County Conservation District with board meeting and day-to-day operations. The board has re-advertised to fill vacant District Manager position.
- Began work on conservation district allocation and the field services budget.
- Completed the paperwork for the renewal of the Workers Compensation bid packet.

SELECTION OF OFFICERS FOR FISCAL YEAR 2019
