STATE GUIDELINES FOR THE CONSERVATION COST-SHARE PROGRAM

PROGRAM YEAR 13

Program Year Begins: September 1, 2011 Program Year Ends: June 30, 2013

Allocation Period Begins: September 1, 2011 Allocation Period Ends: June 30, 2012

> Oklahoma Conservation Commission in cooperation with Oklahoma's 87 Conservation Districts

Approved by the Conservation Commission on ______.

1. GENERAL

The Oklahoma Conservation Commission hereby declares that the following problems are having a detrimental affect on the renewable natural resources of our state:

Oklahoma's water and soil resources are an important foundation of the state's economic infrastructure. Natural climatic events as well as human activity are impacting these two natural resources. As long as farmers and ranchers produce food from the land to feed the world and the wind blows and the rain falls, we will continue to see impacts on soil and water. Our task as stewards of these natural resources is to minimize these impacts. Protecting these vital natural resources is paramount in preserving the state's economic future. In order to accomplish this goal, the Conservation Commission hereby establishes the following goals and objectives to address these problems affecting our renewable natural resources:

Make cost-share funds available to conservation districts so that they can implement cost-share practices which will protect our soil and water natural resources.

The Conservation Commission herein establishes the complete list and description of the conservation Cost-Share Program policies and conservation practices approved for use by the conservation districts during program Year 13. See Section II for the approved list of conservation practices with their respective range of cost-share rates for each of the Conservation Cost-Share Program initiatives. State cost-share average costs (unit cost) are based on Oklahoma Natural Resources Conservation Service (NRCS) data.

Any exceptions from these established Conservation Cost-Share Program policies and guidelines shall be approved by the Conservation Commission.

II. ALLOCATION OF FUNDS

A. Locally Led Conservation Initiative

The Conservation Commission allocates the \$739,391.00 FY 2012 appropriation and \$411,136.00 of the un-obligated balance from previous program years for a total of \$1,150,527.00 to the Conservation Cost-Share Fund for the purposes of providing cost-share payments to eligible participants for implementing approved cost-share conservation practices.

B. Conservation District Allocation

The amount of funds allocated to each conservation district appears in pages 10-12. These funds will be available to conservation districts on September 1, 2011.

III. POLICIES

A. Allocation Period

The allocation period shall start September 1, 2011 and end June 30, 2012. Any funds allocated to districts and not obligated during the allocation period for program year 13

Program Year 13 Guidelines 2

will be released by the district and made available for reallocation by the Conservation Commission. Funds become obligated to a participant after approval of the application by the board and a performance agreement has been signed and dated by the district board and the participant.

B. <u>Authorized/Designated Representatives</u>

The district board must designate an authorized district representative. This person can sign all forms. The authorized district representative must be a district board member. It cannot be a district employee.

The district must designate a technical representative. The designated technical representative will assist in developing conservation plans and determining the need for conservation practices. The representative will also be responsible for design and layout of approved conservation practices, determining compliance with approved standards and specifications, and certifying conservation practice quantities and completion of conservation practices.

C. Conservation Practices

Each district board may select any of the approved cost-share conservation practices within the Locally Led Conservation Initiative for inclusion in the district's local guidelines. The selection should be based on which practices will best address the district's highest priority problems affecting renewable natural resources.

Cost-share practices shall be implemented according to NRCS standards and specifications. In the event NRCS standards and specifications do not exist, conservation practices must meet Conservation Commission approved standards and specifications.

D. Average Costs

State average cost (unit cost) for these practices is based on Oklahoma NRCS data. In order for a variance to be considered the request must be in writing and accompanied by supporting data compiled by the district. The variance rate must be approved by the Conservation Commission prior to the board's approval of Program applications and performance agreements being signed.

E. Cost-Share Payments

The minimum cost-share payment amount that shall be made to any participant from these funds is \$100. The maximum cost-share payment amount that shall be made to any participant from these funds is \$5,000.

F. Cost-Share Rate

The maximum cost-share rate for these practices is 75%. District boards may choose to set cost-share rate less than the specified rate.

G. Eligibility

Applicants for the Conservation Cost-Share Program must be a district cooperator with a conservation plan. The applicant must certify that they own or operate at least 20 acres of land from which more than \$1,000 of soil-dependent products are sold annually.

Conservation Commissioners, Conservation Commission staff, conservation district employees or the spouses of any of these people shall not be eligible to participate in the Conservation Cost-Share Program.

On November 1, 1999 conservation district directors became eligible to participate in the Conservation Cost-Share Program. Due to the limited amount of funds available for program Year 13 individual directors should give careful consideration to public perception when making their decision to participate in the Program. If the local board decides that board members can apply and board members choose to apply for program Year 13 the guidelines below must be followed.

- 1. Individual district board members applying cannot discuss any element of the Cost-Share Program including but not limited to practices, rates, average costs, selection criteria, application approval/disapprovals, cost-share payments, and extensions.
- 2. Individual district board members applying for the Cost-Share Program must abstain from voting on all elements of the Program.
- 3. Individual district board members cannot use their position as a conservation district board member to improve or elevate their individual chances of becoming a successful applicant.

H. Agreements

All program Year 13 performance agreements must be signed and dated by the district board and participant on or before June 30, 2012. All program year 13 performance agreements must be completed and the check in the hand of the participant on or before June 30, 2013. Installation of conservation practices can not begin until an effective performance agreement is in place. A performance agreement becomes effective on the last date of signature. Each participant should have only one performance agreement.

Each participant is required to sign a maintenance agreement. Completion of the maintenance agreement and signature of the participant are required prior to the disbursement of the cost-share payment.

IV APPROVED CONSERVATION PRACTICES

Contained in this section is a list of all conservation practice's approved for use in the program Year 13 Locally Led Conservation Initiative. The conservation district shall only use conservation practices listed here unless a special request is approved by the Conservation Commission. In order for a conservation practice special request to be considered the request must be in writing and accompanied by supporting documentation. The special request must be approved by the Conservation Commission prior to the board's approval of Program applications and performance agreements being signed.

State average cost (unit cost) for these practices is based on Oklahoma NRCS data. In order for a variance to be considered the request must be in writing and accompanied by supporting data compiled by the district. The variance rate must be approved by the Conservation Commission prior to performance agreements being signed.

Below are the conservation practices approved for program year 13.

Program Year 13 Guidelines 4

314 - Brush Management

Definition: Removal, reduction, or manipulation of non-herbaceous plants.

Purpose: This practice may be applied as part of a conservation management system to accomplish one or more of the following purposes:

- Restore natural plant community balance.
- Create the desired plant community.
- Reduce competition for space, moisture, and sunlight between desired and unwanted plants.
- Manage noxious woody plants.
- Restore desired vegetative cover to protect soils, control erosion, reduce sediment, improve water quality and enhance stream flow.
- Maintain or enhance wildlife habitat including that associated with threatened and endangered species.
- Improve forage accessibility, quality and quantity for livestock.
- Protect life and property from wildfire hazards.
- Improve visibility and access for handling livestock.

342 - Critical Area Planting

Definition: Planting vegetation on highly erodible or critically eroding areas.

Purpose: To stabilize the soil, reduce damage from sediment and runoff to downstream

areas.

362 - Diversion (new structures only)

Definition: A channel constructed across the slope with a supporting ridge on the lower

side.

Purpose: To divert excess water from one area for use or safe disposal in other areas.

378 - Pond (new structures only)

Definition: A water impoundment made by constructing a dam or an embankment or by

excavating a pit or dugout.

Purpose: To maintain or improve water quality.

382 - Fencing

Definition: Enclosing or dividing an area of land with a suitable permanent structure that

acts as a barrier to livestock, big game, or people. (Does not include temporary

fences).

Purpose: Exclude livestock or big game permanently from areas that should be protected

from grazing (vegetated and seeded areas, tree planting, wildlife areas,

recreational areas, brush management areas, structural measures, cropland or

other areas requiring special treatment).

NOTE: This practice is to be used only in conjunction with the Pond (378) or as cross fencing for grazing management.

410 - Grade Stabilization Structure

Definition: A structure used to control the grade and head cutting in natural or artificial

channels.

Purpose: To stabilize the grade and control erosion in natural or artificial channels, to

prevent the formation or advance of gullies, and to enhance environmental

quality and reduce pollution hazards.

412 - Grassed Waterway (new structures only)

Definition: A natural or constructed channel that is shaped or graded to required

dimensions and established in suitable vegetation for the stable conveyance of

runoff.

Purpose: To convey runoff from terraces, diversions, or other water concentrations

without causing erosion or flooding and to improve water quality.

512 - Pasture and Hay Planting

Definition: Establishing native or introduced forage species.

Purpose: Reduce soil erosion by wind and/or water.

516 - Pipeline

Definition: Pipeline installed for conveying water for livestock or for recreation.

Purpose: To convey water from a source of supply to points of use.

550 - Range Planting

Definition: Establishing adapted plants by seeding on native grazing land.

Purpose: To prevent excessive soil and water loss and improve water quality.

590 - Nutrient Management

Definition: Managing the amount, form, placement, and timing of applications of plant

nutrients.

Purpose: To supply plant nutrients for optimum forage and crop yields, minimize entry of

nutrients to surface and groundwater, and to maintain or improve chemical,

physical and biological condition of the soil.

NOTE: To be use in conjunction with other approved conservation practices that specifically refer to Nutrient Management (590) for fertilizing.

595 - Pest Management

Definition: Manage weeds (including invasive and non-invasive species) that directly or

indirectly cause damage or annoyance.

Purpose: Minimize negative impacts of pest control on soil resources, water resources,

air resources, plant resources, animal resources and/or humans.

600 - Terrace

Definition: An earth embankment, a channel, or a combination ridge and channel

constructed across the slope.

Purpose: To reduce erosion, reduce sediment content in runoff water, and improve water

quality.

614 - Watering Facility

Definition: a trough or tank, with needed devices for water control and waste water

disposal installed to provide drinking water for livestock.

Purpose:

To provide watering facilities for livestock at selected locations that will protect vegetative cover through proper distribution of grazing or through better grassland management for erosion control. Another purpose on some sites is to reduce or eliminate the need for livestock to be in streams, which reduces livestock waste there.

642 - Water Well

Definition: A well constructed or improved to provide water for irrigation, livestock,

wildlife, or recreation.

Purpose: To facilitate proper use of vegetation on rangeland, pastures, and wildlife areas;

to supply the water requirements of livestock and wildlife; to provide an

adequate supply of water for conservation irrigation; and to provide for human

use at recreation sites.

Thank you for taking the time to express your concerns regarding the personnel actions involving the district manager position for your conservation district.

The result of the discussion from commission members per our teleconference is that you currently have a staff member that serves as the primary administrative position for your district and that the position you are requesting most closely matches that of an equipment manager. Therefore, the Commission will allocate \$12,000 beginning July 1, 2011 in order for the district to hire an equipment manager. The current budget and economic forecasts for future state appropriations dictate that we be extremely conservative in our allocations to conservation districts.

The district determines the hourly rate for this position and may choose to add to the hourly rate from locally earned funds. Under current policy, the individual selected for this position cannot work more than 1599 hours in a 12-month period. If the board is interested in making this a position greater than 1599 hours the remaining costs (benefits and salary) would have to come from local funds. The costs of insurance benefits can range from \$600 to \$1600 per month depending on the number of dependents the individual is carrying on insurance. Other costs to the district include employer's share of retirement, Social Security and Medicare. Please contact the Commission office if you are interested in using local funds to make this a benefitted position between 1600 hours and fulltime.

Thank you for your letter regarding your proposal for a full-time position for your conservation district.

As you probably know the Oklahoma legislature has completed their work on the Fiscal Year 2012 budget. The Commission will be taking an addition 2.9% reduction in their general appropriation budget. This coupled with a reduction in the NRCS contributions agreement and an increase in the employer's share of retirement will result in approximately \$400,000 of additional cuts to the Commission and Districts budgets for the coming year.

The current budget and economic forecasts for future state appropriations dictate that we be extremely conservative in our allocations to conservation districts; therefore we are unable to provide funding for a full-time employee in your district. We are anticipating that the \$12,000 allocation for part-time employment will remain in effect for next fiscal year beginning July 1, 2011.

The District determines the hourly rate for this position and may choose to add to the hourly rate from locally earned funds. Under current policy, the individual selected for this position cannot work more than 999 hours in a 12-month period. If the board is interested in making this a full-time position; the remaining costs (benefits and salary) would have to come from local funds. The costs of insurance benefits can range from \$600 to \$1600 per month depending on the number of family members insured. Other costs to the district include employer's share of retirement, Social Security and Medicare. Please contact us if you are interested in using local funds to make this a full time position.

Therefore, we have not used the \$12,000 that was available nor have we spent the total allocation expenditures of a full-time employee for almost a year.

At the May regular business meeting, we voted to send in a request/proposal to the Commission in hopes that we could work out finding a way to fund this much needed full-time position. We would like for OCC to consider entering into a joint agreement with us to fund a full-time position with benefits. Our proposal is as follows:

- Harper County Conservation District would be responsible for the entire health benefit package for the employee and family.
- OCC would be responsible for the \$11.50/hr wage for 12 months and all other payroll benefits including taxes, retirement & longevity.
- This agreement would be guaranteed by both parties until FY 2016 unless the State receives adequate funds to support the position in full.

We would appreciate you taking action on this as soon as possible. If you have any questions, please feel free to contact us.





FY 2009 AML SIMPLIFIED GRANT - The following is the status report on the submitted projects:

1. Farley - 085 (Sequoyah County)

Sequoyah County Conservation District has completed planting the Farley site which also included some erosion repair work and planting on the adjacent Hacker site to the north. Work on the southerly property (Smithson) site has been completed and is also planted. The site will be monitored on a monthly basis or at intervals of 0.5 inches of rainfall or more until 70 percent vegetation is established.

2. Bronson - 071 (Rogers County)

All reclamation work has been completed and the site has been planted. The project will be monitored as per AML Program guidelines.

FY 2010 AML SIMPLIFIED GRANT - The following is the status report on the submitted projects:

1. Shouse - 251 (Rogers County)

The vegetation cover of 70 percent has been established and ODEQ has terminated the construction storm water permit. The project will be monitored over the next two years per AML Program guidelines. Extreme heat and lack of rain may require the site to be replanted.

2. Azbill - 246 (Rogers County)

The contractor, Thomas Construction, Inc., completed all work on June 30 and a final inspection and acceptance of the project occurred on July 8. The site will be planted in the fall.

3. Reves Phase 2 South - 101 (Sequoyah County)

As of August 19, the contractor, Goad & Sons Construction LLC, has completed approximately 71 percent of the work in 58 percent of the contract time. The contractor has completed 90 percent of the earth fill. Progress is beginning to slow since the haul distance is increasing. The Contractor delivered the wrong gage of pipe, which was rejected. September work will include installation of 3-38"x53" culverts and raising the grade of the road approximately 5 feet. The contractor's progress is being monitored closely. The contract time is 400 calendar days with the completion date of February 20, 2012.

4. Peevyhouse - 140 (Haskell County)

The Notice to Proceed was issued to the contractor, LLG Construction, Inc., on July 14, and the contractor began work on Monday, July 18. The project will reclaim approximately 18.5 acres of land and should be completed before the middle of December.

5. Bates/Fullerton - 259 (Rogers County)

The Office of Surface Mining has previously provided an Authorization to Proceed. The landowner has signed the right-of-entry agreement. Final plans approved for bidding were submitted by Cobb Engineering (Oklahoma City) on August 23, 2011. The project will be advertised in September and will specify that work will not start until after hunting season. Start of construction is anticipated in early January of 2012.

FY 2011 AML SIMPLIFIED GRANT - On June 7 the Conservation Commission submitted the first reclamation project for this grant to the Office of Surface Mining. The project is the Wilson UM - 185 AML Project, located in Latimer County. The Office of Surface Mining must now issue the authorization to proceed before work can begin on site. The following is the status report on the submitted projects:

1. Wilson UM - 185 (Latimer County)

This Wilson UM (underground mine) site is located Latimer County less than 3 miles from the city of Wilburton (population - 2,972). The site is less than one mile from State Highway 2. When the OCC inspected the site an extremely hazardous site with vertical air shaft (VO) with water starting about 10 feet from the top of the mine shaft was found. The shaft is 18 feet long, 10 feet wide, and approximately 40 feet deep. However, a 1930 mine map for the MK&T Coal Company shows the depth of the shaft as 305 feet. The shaft is even with the surface of the ground and has vertical sides with no way of getting out if a person fell into the shaft. There are two houses within a half mile of the site.

The following reclamation action is being proposed at site: The opening will be excavated with a trackhoe and dozer. Rock as well as on-site clinker/red dog will then be packed in the hole with shale and clay placed on top of the rock. All rock, shale, and clay will be obtained from an off-site commercial facility. The disturbed areas will be graded and shaped to conform to the adjacent topography, and a permanent vegetative cover of grass and/or trees and shrubs will be planted.

The reclaimed site will be approximately 0.2 of an acre with a cost estimate of \$15,000 to \$25,000.

FUTURE PROJECTS

1. McSpadden – 026 (Rogers County)

A partial end fill of this pit occurred in 1985 near a 90-degree roadway curve. This project is approximately 17 acres. The highwall is as close as six feet to the roadway and is actively undercutting and getting closer to the roadway edge. This site is being reviewed by the State Reclamation Committee. The site must be surveyed and environmental clearances obtained. Design for this site will be completed in-house.

2. Reves Phase 2 North - 102 (Seguoyah County).

This 20-acre project site is on the north side of the road, opposite the 80-acre Reves Phase 2 South project site. The project information has been sent to the Reclamation Committee agencies for their review and comment. It is anticipated that this project will be bid in the fall of 2011. The estimated cost of this project is \$200,000

3. Paspotnik UM - 199 (Latimer County)

The Raspotnik underground mine site is located approximately 3 miles northwest of Gowen in Latimer County. The site is a subsidence that is open with vertical sides, 7 feet in diameter by 11.5 feet deep, and appears to open into the underground coal mine. The subsidence hole is close to Clonsilla Hill Road in an open pasture visible from the road making it an attractive nuisance. There are 12 houses within a half mile of the site. Rock is being removed from a quarry and truck drivers haul rock within 20 to 30 feet of the open subsidence hole. The landowner has trespassers on his property numerous times through out the year and fears that someone will fall into the open subsidence hole. The project information has been sent to the Reclamation Committee agencies for their review and comment.

4. Bacon - 252 (Rogers County)

This project site is approximately 37 acres located adjacent to HWY 28, one mile south of the Nowata County line. The design (in-house) should be completed by mid August. OSM Alton is preparing the environmental documentation for permit approval and requested that a ABB study be prepared. Eagle Environmental Consulting, Inc., is conducting the survey for the American Burying Beetle (*Nicrophorous americanus*). It is anticipated that this project will cost approximately \$550,000 and will be bid in the winter of 2012.

5. Northeastern State University - 166/180 (Wagoner County)

The conceptual plan has been prepared and reviewed with NE State University on July 21. The conceptual plans will be submitted with the environmental assessment (EA) to the appropriate agencies for review. A survey for the presence or absence of the American Burying Beetle (ABB) (*Nicrophorous americanus*) was completed July 8 by Eagle environmental Consulting, Inc. No ABBs were captured during the survey effort. The preliminary design is due in the OCC office on August 31.

6. Reves Phase 3 - 101/102 (Seguoyah County).

This project site is approximately 65 acres and is adjacent to the east side of Phase 2 South. The estimated cost of this project is approximately \$850,000.

7. Greer Phase 3- 208 (Rogers County)

The Greer abandoned mine land site is a 65-acre site located 4 miles south of the town of Claremore (pop. 13,280) and 2 miles northeast of the town of Verdigris in Rogers County. The site is just west of Historic U.S. Highway 66. An industrial park is within 100 yards of the south end of the site. There is a new housing addition adjacent to the east side of site. There is approximately 3,600 feet of dangerous highwall (DH) up to 70 feet high, and one 8.5-acre water-filled strip pit at the site. The project is currently being designed by the AML Program Engineer. The estimated cost is approximately \$850,000. This project is scheduled for 2013.
