


Know Your Stream: Rotating Basin Site Summary

Noble & Pawnee Counties, Central Great Plains Level 3 Ecoregion

The Oklahoma Conservation Commission (OCC) has the statutory responsibility of monitoring streams across the state in order to identify healthy streams as well as those which may be impacted by non-point source (NPS) pollution. NPS pollution is pollution which runs off the land from diffuse sources rather than being discharged from a specific source. If a stream is found to be impaired by NPS pollution, the OCC may be able to implement a voluntary cost-share program to address the identified problems; however, streams must be monitored in order to select best management practices necessary for improvement. The OCC's "Rotating Basin Monitoring Program" provides the tools to assess and then restore water quality in Oklahoma.

This leaflet gives a brief summary of the assessment results for the second 2-year cycle of the monitoring program for streams in Noble & Pawnee Counties. Through the Rotating Basin Program, five streams in Noble & Pawnee Counties were sampled approximately every five weeks from June 2007-May 2009. Eighteen water quality parameters were measured or analyzed at each site visit. In addition, OCC staff conducted one fish and habitat assessment and up to four macroinvertebrate collections. Summer samples were also analyzed for *E. coli* and *Enterococcus* bacteria. Each site was compared to "high quality" streams in the ecoregion, streams known to have high quality fish populations, benthic macroinvertebrate populations, instream and riparian habitat, and water quality. All of the data collected has been distilled into a few key components in order to produce an index score of general, overall stream health, shown on the next page.

Note: Most streams in Oklahoma are impaired by at least one type of bacteria.

Black Bear Creek (Middle) (OK621200-03-0010M): This stream is impaired by state standards for elevated turbidity, bacteria levels and poor quality fish community. All other parameters are comparable to high quality streams in the ecoregion.

Black Bear Creek (Lower) (OK621200-03-0010D): This stream is impaired by state standards for elevated turbidity, bacteria levels and poor quality fish community. All other parameters are comparable to high quality streams in the ecoregion.

Red Rock Creek (Lower) (OK621200-05-0010K): This stream is listed as impaired by state standards for elevated turbidity, salts and bacteria levels. The phosphorus levels were slightly elevated compared to high quality sites. All other parameters were comparable to high quality sites in the area.

Red Rock Creek (Upper) (OK621200-05-0160G): This stream is listed as impaired by state standards for elevated turbidity, salts and bacteria levels. The phosphorus levels were slightly elevated and the macorinvertebrate community was of slightly lower quality relative to high quality sites.

Black Bear Creek (Upper) (OK621200-03-0010W): This stream is impaired by state standards for elevated salts, bacteria levels and poor quality fish community. The phosphorus levels were slightly elevated and the instream/riparian habitat was of slightly lower quality than the high quality sites in the ecoregion.
