# MINUTES OF PREVIOUS REGULAR MEETING

# RECOGNITION OF COMMISSION EMPLOYEE

# LOCALLY LED CONSERVATION COST-SHARE PY 24 GUIDELINES

Ms. Marshall recommended approval of the Program Year 24 Cost-Share guidelines as presented in Exhibit #4. Ms. Marshall stated that the Commission is recommending to allocate \$2 million of cost-share funds for Program Year 24 with the allocation period set for December 6, 2021 – April 30, 2022. Staff is proposing that each district receive \$30,300.00 to initiate the program. Ms. Marshall noted that there will be another opportunity to receive cost-share funds after the allocation period has ended for Program Year 24. After discussion, a motion was made by Mr. Herald, seconded by Mr. Crawley, to approve the Cost-Share Program Year 24 guidelines as presented in Exhibit #4. Those voting aye were: Herriman, Herald, Campbell and Crawley. Nay votes: none. Motion carried.

# POULTRY LITTER TRANSFER PROGRAM GUIDELINES

Ms. Phillips recommended approval of the 2022 Litter Transfer Guidelines as presented in Exhibit #5. Ms. Phillips noted that beginning January 2022 the Oklahoma Conservation Commission will support the 2022 Poultry Litter Transport Program. The program provides three payments to incentivize litter transfer out of areas where litter has been produced and historically applied in greater concentrations to areas of the state where litter could be used with a lower risk to downstream waterbodies. The first payment incentivizes the poultry grower to sell litter to a qualified buyer by subsidizing the cost of replacement bedding at \$2/ton; The second payment goes to the buyer to help offset cost of transporting product at rate of \$0.08/ton/mile for locations within 100 miles from the grower; the final payment will be to conservation districts that help buyers and sellers ensure compliance with state and program rules. Litter transport will only be funded if produced in and transported to Oklahoma. The Oklahoma Conservation Commission would like to help increase litter use by a wider variety of producers and in further ranging portions of the state to help build soil organic matter and increase soil health. Rules, as well as more detailed maps of litter eligible areas will be sent to districts by December 10, 2021. Additional program limitations include \$10,000 cap for buyers on the purchase of litter, and the repayment will only subsidize transport up to 250 miles from its production location. Ms. Phillips stated interested individuals can go to the Oklahoma State University website as the website has organized contact information for litter brokers and certified litter applicators. After discussion, a motion was made by Mr. Campbell, seconded by Mr. Crawley, to approve the 2022 Litter Transfer Guidelines as presented in Exhibit #5. Those voting aye were: Herriman, Herald, Campbell and Crawley. Nay votes: none. Motion carried.

# CONSERVATION PARTNERSHIP REPORTS

Oklahoma Department of Agriculture, Food and Forestry: Janlee Rowlett, Legislative Liaison, reported on the following items- No report available.

USDA-Natural Resources Conservation Service: Gary O'Neill, State Conservationist, reported on the following items-

- Staffing updates Stacey Riley is serving as the State Conservationist in Nebraska for 120 days; Brooke Taylor will be acting Assistant State Conservationist for Programs during Stacy's detail; Brent Pannell, Assistant State Conservations for Field Operations is handing COVID issues; Andy Bennett, CSP Program Manager is on detail to the national office. During Andy's absence, Tiffany Green, will serve as the acting CSP Program Manager; Josh Ketch is Assistant State Conservationist for Management and Strategy. Mr. Ketch's job responsibilities include handling agreements, budget, leases, HR, and procurement.
- Programs NRCS staff is working on CSP renewals, CSP payments, CSP grassland, EQIP planning and writing CRP plans.
- Watershed Program Infrastructure Reinvestment and Jobs Act. Been on several calls as to how funding can be requested. There will be informational calls for partners and sponsors. The Act has \$500M in watershed operations, \$118M watershed rehab and funds for EWP.

# OKLAHOMA CONSERVATION COMMISSION MEMBERS

Mr. Herald – dry climate; no major erosion. Participated in Area I meeting and went well.

Mr. Herriman – dry climate; harvest went well. Introduced George Stunkard in board meeting.

Mr. Crawley – dry climate; concerned about pond water levels. Area 5 meeting went well.

Mr. Campbell – participated in Governor's Water Conference; great experience. Participated in Governor's Veterans Symposium and got to meet Senator Murdock. Participated in the Small Farmers Conference hosted by Oklahoma Black Historical Research Project Incorporated.

# OKLAHOMA CONSERVATION COMMISSION STAFF

Executive Director: Mr. Lam reported the following items:

- OACD Area Meetings Participated in all area meetings; successful.
- State Meeting Planning- Had first meeting and focus will be on regenerative agriculture.
- -Neighbors Helping Neighbors Participated in meeting; water quality is working with GRDA on this program.
  - -National Watershed Coalition Participated virtually in meeting.
- -Budget Hearing Meeting is set on December 14, 2021; Subcommittee will be in attendance.
- American Rescue Plan Act Federal funds are available, and staff has been asked to put together a proposal to submit to legislature.

Water Quality Program: Shanon Phillips, OCC Water Quality Division Director, stated that there was a report in the packet. Ms. Phillips recognized Greg Kloxin, Maryanne Dantzler-Kyer and Clancy Green for help with technical assistance to make sure the Area meetings ran smoothly. Following presentations at the Area III and Area IV meetings there has been a lot of interest in Soil Health Poultry Litter Demonstration Farm Program. Applications will be mailed out to conservation districts in December, seeking two farms in Northeastern Oklahoma and two farms in Southeastern Oklahoma to demonstrate benefits of poultry litter application with soil health, regenerative agriculture practices. Ms. Phillips stated the Oklahoma Conservation Commission was sad to lose Soil Health Program Coordinator Amy Seiger to new opportunities. A job description has been drafted and will be advertised soon to fill the Soil Health Program Coordinator position to continue support of the soil health program.

Office of Geographic Information and Technical Services: Mike Sharp, Director, stated that there was a written report in the packet and would be happy to answer any questions. Mr. Sharp stated that work continues on the NG911 program and OK Maps. Mr. Sharp got the opportunity to meet with Representative Grego to discuss the NG911 program and help address concerns.

Abandoned Mine Lands Reclamation: Robert Toole, Director, stated that a written report was in the Commissioner's packet. Mr. Toole summarized the November 2021 AML Program activity stating construction is on-going on two (2) projects; contracting is on hold for 2 projects pending funding; vegetation management & maintenance monitoring is being performed on seven (7) projects; seven (7) projects are in the design phase; five (5) sites are in realty phase; one (1) maintenance project is in contract process and one (1) completed project has had the Right-of-Entry withdrawn by the landowner who wants to re-assume operation and maintenance of the site for personal use.

Conservation Programs: Tammy Sawatzky, Director of Conservation Programs reported on the following items:

- Interview with Bobcat Johnny Pelley and George Moore participated in an interview with Bobcat to discuss equipment utilized by the Conservation Program Division. The information from the interview will be displayed on the website and other publications as a testimony to Bobcat equipment.
  - Paige Porter has been planning a training day with the watershed aides.
- Rehab work Cottonwood 54 almost done, finishing with clean up; Upper Elk 23D going well and contractor is doing a good job; Fourche Maline 7M land rights have been completed. Ms. Sawatzky noted the goal is to start construction in the next 3-6 months; cost to complete work

on the Fourche Maline 7M is about \$14 million.

Assistant Director: Lisa Knauf Owen reported on the following items:

Ms. Owen stated that the National Watershed Coalition (NWC) held an annual meeting which was 100% virtual this year. Three hundred people had registered for the two- half day sessions. Mr. Lam facilitated a panel discussion on aging components of structures that in Oklahoma included corrugated metal pipe; Ms. Owen facilitated a panel discussion on climate change with NACD's Climate Task Force. Ms. Owen is working with OMES to recover federal funds that were applied to other state agencies federal debt. It is an ongoing process. Ms. Green is working with new hires in Muskogee, Lincoln and Cotton Counties. Ms. Owen introduced the feral swine technicians and discussed ongoing progress with the project.

# STATE GUIDELINES FOR THE CONSERVATION COST SHARE PROGRAM

PROGRAM YEAR 24

Program Year Begins: December 1, 2021 Program Year Ends: April 30, 2023

Allocation Period Begins: December 1, 2021 Allocation Period Ends: April 30, 2022

Oklahoma Conservation Commissionin cooperation with Oklahoma's 84 Conservation Districts

Approved by the Conservation Commission on December  $6^{th}$ , 2021.

# I PURPOSE

The Oklahoma Conservation Commission hereby declares that the following problems have adetrimental effect on the renewable natural resources of our state:

Oklahoma's water and soil resources are an important foundation of the state's economic infrastructure. Natural climatic events as well as human activity are impacting our natural resources. Additionally, feral swine are a common nuisance in Oklahoma that have a devastating impact to natural resources. As long as farmers and ratesproduce food from the land to feed the world and the wind blows and the rain falls, we will continue to see impacts on soil and water. Our task as stewards of these natural resources is to minimize these impacts. Protecting these vital natural resources is paramount in preserving the state's economic future. In order to accomplish this goal, the Commission hereby establishes the following goals and objectives to address these problems affecting our renewable natural resources:

Make cost share funds available to conservation districts for the purpose of providing cost share payments to landowners and operators implementing conservation practices which will protect our soil and water natural resources.

Make cost share funds available to conservation districts for the purpose of purchasing an electronic hog trap to assist landowners and operators in reducing theferal swine population on their lands.

The Commission herein establishes the Conservation Cost Share Program Guidelines for Program Year 24. Any exceptions from these established guidelines shall be approved by the Commission.

# II ALLOCATION OF FUNDS

The Commission allocates \$2,600,000 of cost share funds for Program Year 24. Each district will be given the opportunity to allocate \$30,300.00. The Commission will make these funds available to participating conservation districts upon receipt and approval of the district's Program Year 24 local priorities and application ranking system.

Districts will have an opportunity to request additional funds after the allocation period as ended. Requests will be accepted from May 1-13, 2022, notification of approval will be made no later than May 31, 2022. Full funding will not be guaranteed.

# A. Locally Led Conservation Initiative

The total budget for the locally led conservation initiative is \$2,550,000. Eligible landowners and operators may apply at their local conservation district for cost share funds for the purpose of implementing approved conservation practices to protect soil andwater natural resources.

# B. Reduction of Feral Swine Population

The total budget for the feral swine initiative is \$50,000. Only conservation districts are eligible to apply to the Commission for cost share funds for the purpose of purchasing anelectronic hop trap to assist landowners and operators in reducing the feral swine population on their lands.

# III LOCALLY LED CONSERVATION INITIATIVE PROGRAM POLICIES

# <u>Conservation District Participation</u>

The Cost Share Program (CSP) is a voluntary program. Conservation districts are not required to participate. To participate in the CSP the conservation district board must take action in a regularly scheduled district board meeting. CSP funds allocated to conservation districts that choose not to participate will be returned to the Commission for reallocation to other districts.

# Carry Over Funds

Conservation districts will not be allowed to carry over unobligated Program Year 23 funds to Program Year 24.

# Program Year

Program Year 24 begins on December 6, 2021 and ends on April 30, 2023. All Performance and Maintenance Agreements must be completed, and cost share payments disbursed by April 30, 2023. The Commission will not process claims received after April 30, 2023.

# **Allocation Period**

The allocation period is the period in which a conservation district has to obligate their program year allocation. The Commission has established December 6, 2021 through April 30, 2022 as the allocation period for Program Year 24. If a conservation district fails to obligate all of their allocation by April 30, 2022, unobligated funds will be withdrawn and made available for reallocation to other districts. Funds become obligated when an application has been approved for funding by the conservation district board and a Performance and Maintenance Agreement has been signed and dated by the district board andthe applicant.

# Requests for Additional Funding

Requests for additional funding will be accepted May 1-13, 2022, notification of approval will be made no later than May 31, 2022. The request must be submitted via email and include a formal request letter from the district board stating the exact amount requested. A copy of the district's Allocation Report must be attached. Full funding will not be guaranteed.

# **Eligibility Requirements**

Applicants for cost share funds must be a conservation district cooperator with a conservation plan Applicants must agree to maintain the conservation practice for the expected life specified by the conservation district. Applicants that lease the land must submit a landowner consent form with their application. The landowner must agree to

continue maintenance of the conservation practice for the expected life specified by the conservation district in the event that the land lease agreement is canceled Conservation Commissioners, Conservation Commission staff, conservation district employees or the spouses of any of these people shall not be eligible to participate in the Conservation Cost Share Program.

Conservation district directors are eligible to participate in the Conservation Cost Share Program. Due to the limited amount of funds available for Program Year 24 individual directors should consider public perception when making their decision to participate in the Program. Each participating conservation district must submit to the Commission a Director Participation form documenting the district board's vote related to board members participation in the CSP. If the district board votes to allow board members to apply for cost share funds the guidelines below will be followed.

- 1. Only two conservation district board members can apply for cost share funds during Program Year 24.
- 2. Individual district board members applying cannot discuss any element of the CostShare Program including but not limited to practices, rates, average costs, selection/ranking criteria, application approval/disapprovals, payments, and extensions.
- 3. Individual district board members applying for the cost share funds must abstain from voting on all elements of the Program.
- 4. Individual district board members cannot use their position as a conservation district board member to improve or elevate their individual chances of becoming a successful applicant.

# Authorized District Representative

The conservation district board must designate an authorized district representative. This person can sign all forms. The authorized district representative must be a conservation district board member. It cannot be a conservation district employee. The board can designate methan one district board member as the authorized district representative. Board members applying for cost share funds cannot serve as the authorized district representative.

# Technical Representative

Natural Resources Conservation Service (NRCS) staff will serve as the conservation district's technical representative. They will assist the conservation district by conducting field visits to determine landowner needs, participating in the application review process, developing conservation plans, design and layout of practices when required, determining compliance with NRCS conservation practices standards and specifications, and certifying practice quantities. The technical representative will be required to sign the Certification of Completion and Acceptance form.

# 325 High Tunnels

Each conservation district board may select any of the approved conservation practices for inclusion in the conservation district's local program. The selected practices should address the conservation district's identified priority resource concerns. A conservation district can request Commission approval to add conservation practices not included in the list of approved practices. The request must be submitted to the Commission in writing and be accompanied by supporting data compiled by the conservation district. The requested practice must be approved by the Commission prior to the district board's approval of CSP applications.

Conservation practices shall be implemented according to NRCS standards and specifications.

CSP average costs (unit cost) for the conservation practices is based on Oklahoma NRCS data. A conservation district can request an average cost variance. The request must be submitted to the Commission in writing and be accompanied by supporting data compiled by the conservation district. The requested variance rate must be approved by the Commission prior to the district board's approval of CSP applications.

# **Maximum Cost Share Payment**

The maximum cost share payment amount per participant in Program Year 24 is \$7,500. Each conservation district board may choose to establish a maximum cost share payment amount that is less than \$7.500.

# Maximum Cost-Share Rate

The maximum cost share rate for all conservation practices is 85%. Each conservation district board may choose to establish a cost share rate less than 85%.

#### Local Program Priorities and Application Ranking System

The CSP gives conservation districts the responsibility to determine the recipients of state cost share funds. To meet this responsibility conservation districts must establish local program priorities. Clearly understood priorities make the approval process much easier and minimize possible misunderstandings.

Conservation districts must develop an application ranking system that will be used during the application approval process. The ranking system should address applicant eligibility requirements first to determine if additional consideration towards approval is necessary. Conservation district staff and technical representatives based on best professional judgment and site-specific evaluations should provide information to assist the district board during the application ranking process.

#### District Ranking Systems to be due by Feb 28th, 2022.

Each conservation district must submit their local program priorities and application ranking system for the Commission's review and approval prior to starting the application process. Cost share funds become available to conservation districts for obligation after the Commission approves their local program priorities and application ranking system.

#### **Application Process**

Conservation districts should advertise the availability of CSP funds throughout the district. The following information should be included in your advertisement: application period, maximum allowed payment, cost share rate, conservation practices available, and district contact information. Advertisement can be in the form of a local newspaper article, newsletters, announcement of the district's Facebook page, flyers at business in the district, or word of mouth. Any costs associated with advertising your local CSP can be reimbursed from your other operating funds.

Potential applicants must return completed applications to the district prior to the end of the district's application period. Applicants that lease the land must submit a landowner consent form with their application. Each applicant is limited to one application. Multiple practices can be applied for on one application.

#### **Approval Process**

Conservation districts must use their program priorities and application ranking system to make CSP funding decisions. Applications must be approved during an official conservation district board meeting. Board meeting minutes must include a list of approved applications showing the approved applicant's name, practice, and maximum cost share amount.

Approved applicants must be notified, in writing, within 10 days after conservation district board action. Applicants should be instructed to contact the conservation district to set up an appointment to sign a Performance and Maintenance Agreement, IRS W9 Form and schedule a field visit.

Conservation districts that have more qualified applications than available CSP funds may

choose to approve those applications as alternates on the condition that funding becomes available. Alternates must be notified, in writing, within 10 days after conservation district board action. Approved alternates should be instructed to contact the conservation district to set up an appointment to sign a Performance and Maintenance Agreement prior to April 30, 2022. Work cannot begin until notified by the conservation district that funds are available. All approved alternates must understand that there is no guarantee that funds will become available during the program year. Applicants denied for any reason must be notified, in writing, within 10 days of the district board decision. The conservation district board must give reason(s) for the denial and advise the applicant of their right to appeal and the procedures necessary to exercise those appeal rights.

#### **Appeals Process**

Applicants denied CSP funds has the right to appeal the conservation district's decision. The conservation district board has 30 days in which to respond to an applicant appeal. The conservation district board must hear an appeal in a regularly scheduled district board meeting. Appeals must be listed on the agenda and heard in open session; no appeals shall be heard or discussed in executive session. The conservation district board should give the applicant an opportunity to be heard, that is, what is the reason for contesting the decision. If the conservation district board agrees with the applicant, then the district board can reverse its earlier decision and approve the application. However, if the conservation district board feels that its original denial of the application was justified, the district board is certainly entitled to stand by its original ruling. In that case the applicant must be notified in writing, that the conservation district board's decision can be appealed to the Commission.

Appeals to the Commission must be made, in writing, within 30 days of the conservation district board's decision. The conservation district must forward to the Commission a copy of the case file, the application ranking system used by the district, and the reasons for the district board's denial.

#### **Completion Dates**

Conservation districts shall set and enforce completion dates for approved applicants and inform the applicant of that date. The applicant should make every effort to complete approved practices by the established completion date. Applicants that have not started, are not under construction, or have not completed implementation of practices by the established completion date can be canceled in order to reallocate funds to an approved alternate.

Conservation districts may make applicants that were canceled for lack of completion effort ineligible for CSP funding in future program years. When mitigating circumstances influence an applicant's ability to complete implementation, conservation districts can reconsider the applicant's ineligibility for CSP funding in future program years.

#### **Execution of Performance and Maintenance Agreement**

The Performance and Maintenance Agreement shall require the applicant to meet the following requirements:

- To perform or have performed all work described in the Conservation Plan in accordance with NRCS conservation practice standards and specifications.
- To submit to the district a detailed, itemized statement of costs and copies of contractor's invoices when the conservation practice(s) are constructed by a contractor.
- To submit to the district detailed invoices for applicant in-kind contributions.
- To complete or have completed all work described in the Conservation Plan by the completion date established by the district.
- To obtain all required permits and approvals prior to the construction of the conservation practice(s).
- To permit free access to the applicant's land for district and NRCS representatives to inspect the conservation practice(s) upon completion.
- To maintain, at no cost to the district, the conservation practice(s) as designed and constructed for the expected life as set forth by the district. If the applicant removes, destroys, or does not maintain the practice(s) before the end of its expected life, the district shall be authorized to recover the CSP funds disbursed. The applicant shall remain ineligible for future CSP funding until the practice(s) is properly maintained, CSP funds are recovered by the district, or the expected life of the practice(s) expires.
- To accept the district's method of calculating the cost share payment for completed work.
- To complete and attach an IRS W-9 Form-Request for Taxpayer Identification Number and Certification.

After an applicant has been notified, they have been approved for CSP funds, the applicant and conservation district must execute a Performance and Maintenance Agreement. An agreement number following the Commission approved format must be assigned to each agreement.

Example agreement number – 03-024-001

03 - conservation district number

024 - program year number

001 – applicant number assigned by the district

All Program Year 24 Performance and Maintenance Agreements must be signed and dated by the conservation district board and applicant on or before April 30, 2022. All Program Year 24 Performance and Maintenance Agreements must be completed and the CSP claim submitted to the Commission on or before April 30, 2023. Installation of conservation practices cannot begin until an effective Performance and Maintenance Agreement is in place. An agreement becomes effective on the last date of signature. Each applicant can have only one Performance and Maintenance Agreement.

#### **Practice Failures**

Practice failures may occur due to unusual weather conditions, such as drought or severe storms that are beyond the control of the applicant. If the practice has been certified complete and fails due to an extreme act of nature during the expected life, the applicant may apply for CSP funds in future program years for the same practice.

#### **Agreement Violations**

If a violation of a Performance and Maintenance Agreement is alleged a representative of the conservation district and/or a representative of the Commission will investigate. If the investigation determines a violation has occurred, the conservation district shall notify the applicant in writing. Notification must include a description of the violation, corrective action required, and date corrective action should be complete. The conservation district shall be authorized to recover all CSP funds disbursed to the applicant if corrective action is not taken. The applicant shall not be given more than 45 days to make repayment. If the applicant does not make repayment, the conservation district shall contact the Commission for further guidance.

#### **Cost Share Claim Process**

A cost share claim can be submitted to the Commission after certification of practice implementation has been completed and the applicant has submitted all relevant receipts. Multiple completed agreements can be submitted on the same cost share claim. For each agreement listed on the claim a copy of the following back-up documentation must be attached to the claim.

- All relevant invoices and in-kind documentation (Claims will not be processed for payment without proper documentation)
- Performance and Maintenance Agreement
- Consent (if applicable)
- Certification of Completion and Acceptance (Must include Lat/Long Coordinates)
- Payment Calculation Sheet
- Signed Conservation Plan (Copies of maps are not needed, only the plan and signature page)

Cost share claim reimbursements will be made to the conservation district by EFT. The conservation district will issue a district check to the applicant for the approved payment amount. The Commission cannot process Program Year 24 claims received after April 30, 2023.

Conservation districts must provide an IRS Form 1099-MISC to any applicant receiving \$600 or more in payment(s) from the district during a calendar year. In accordance with IRS regulations conservation districts must file a copy of each IRS 1099-MISC form along with IRS Form 1096 with the Internal Revenue Service. Neither the conservation district nor the Commission provides tax advice; the applicant may wish to consult with an independent tax advisor regarding any potential tax consequences.

#### IV REDUCTION OF FERAL SWINE PROGRAM POLICIES

#### **Eligibility**

Only conservation districts are eligible to apply for CSP funds for the purpose of purchasing an electronic or manual hog trap to assist landowners' in reducing the feral swine population on their lands.

#### **Available Monies**

The Commission has set aside \$50,000 of CSP funds for the feral swine initiative.

#### **Application Process**

Conservation districts applying for CSP funds for the purchase of electronic hog traps shall submit a business plan to the Commission for approval. Business plans are due in the Commission office no later than May 1, 2022.

- 1. <u>Preparation</u> Before preparing the business plan the conservation district board and staff must be familiar with the Feral Swine Control Act and promulgated rules, as well as state carcass disposal requirements.
- 2. <u>Business Plan</u> The business plan must include:
  - Make and model of the electronic hog trap.
  - A current (less than 3 months old) cost quote for the electronic hog trap. The
    quote must include cost for the entire trap. Quotes for only gates and cameras
    are not accepted as the Cost Share Program will only fund entire traps
  - A policy statement that details responsibilities for assembly and de-assembly of the trap, upkeep, maintenance, transportation of the trap to and from locations, and resetting of the trap. The conservation district should restrict renters from performing maintenance on the equipment.
  - A proposed rental plan that sets rental period and how costs shall be assessed (per day, weekly, or monthly rate). The rates will need to include any charges for assembly, de-assembly, resetting, transportation, mobile phone or wireless costs, normal wear and tear on the trap, maintenance, and possible damage to equipment not covered by insurance.
  - A statement verifying that the conservation district has adequate staffing resources to maintain the equipment and implement the trapping program in the district.
  - Operator must understand and agree that if any personal or property damage or injury were to occur while the hog trap is in their possession, they cannot hold the District or any of its director's or employees liable in any way. After the hog trap is delivered and set up at the chosen location, the operator must assume any and all liability, and the operator must also assume any and all liability until the return of the hog trap back to the district.
  - A draft copy of the conservation district's comprehensive hog trap rental agreement that provides clear instructions on use, responsibilities, liabilities, and safety to renters. The rental agreement must include the link to the Oklahoma Department of Agriculture, Food, and Forestry website regarding feral swine laws and rules. The conservation district must provide renters information about

proper disposal of hogcarcasses pursuant to state statutes.

3. Restrictions - When a conservation district decides to sell an electronic hog trap purchased with CSP funds they must notify the Commission before placing the trap for sale. All monies from the sale must be reported to the Commission and can only be used by the conservation district to fund CSP applicants in future program years.

#### **Approval Process**

Commission staff have 30 days to review the business plan. Conservation districts will be notified in writing of the Commission's decision.

#### V ADMINISTRATIVE GUIDELINES

#### **District Reporting and Accounting**

Conservation districts shall conduct the following reporting and accounting procedures

- 1. Maintain a Cost Share Program Allocation Report in electronic format. The report should include data for all conservation district board approved Performance and Maintenance Agreements. Agreements approved as alternates must be labeled as 'alternate'. The report should include the following:
  - conservation district name
  - applicant's name
  - agreement number
  - expected completion date
  - obligated amount
  - agreement effective date

## 2. Submit the Cost Share Program Allocation Report to the Commission for review on or before April 30, 2022.

- 3. Assemble case files for each approved applicant containing the following
  - Approved application
  - Application ranking form
  - Certificate of Completion and Acceptance form
  - Performance and Maintenance Agreement
  - Conservation Plan
  - Copy of cost share claim
  - Consent form
  - Applicant's receipts and in-kind documentation
  - Final practice design
  - Map locating the practices
  - Documentation of communication (verbal and written) with the applicant

#### **Commission Reporting and Accounting**

The Commission shall conduct the following reporting and accounting procedures:

- 1. Receive and review Cost Share Program Allocation Reports from conservation districts.
- 2. Receive and review requests for additional funding May 1-13, 2022.

- 3. Notify districts of additional funding approval no later than May 31, 2022.
- 4. Receive and review requests for extensions past PY 24 end on April 30, 2023 and notify districts of OCC's decision.

#### V APPROVED CONSERVATION PRACTICES AND AVERAGE COSTS

Program Year 24 approved conservation practices and average costs can be found on pages 13-17. #### 2022 Litter Transfer Rules

Beginning January 1, 2022, the Oklahoma Conservation Commission (OCC) will support the transfer of poultry litter out of nutrient-impacted watersheds to areas where land application poses a lower risk to downstream water resources. This program will provide an incentive to the poultry grower to sell litter to a qualified buyer but also to the buyer to help offset the cost of transport.

All Oklahoma rules related to poultry litter application must be complied with including rules related to application rates, application licensing, litter storage if immediate application is not possible, and others. All litter application must be completed by a licensed applicator.

Nutrient-impacted watersheds as depicted in the map below include both watersheds where litter application is not eligible for the program (red) and watersheds where litter application is only eligible on cropland (orange).

Only litter from poultry operations in Oklahoma sold to buyers for land in Oklahoma is eligible for participation in the program.

Buyers and sellers will work with local conservation districts to arrange litter transport and ensure compliance with litter.

Steps for Litter Transfer Approval:

- 1. Buyers interested in participating in the program should contact their conservation district to make an application. Districts will send name and address of the buyer and estimated tons of litter to Ed Crall at OCC for preapproval. Districts will provide the potential buyer with a copy of the Oklahoma Department of Agriculture, Food and Forestry (ODAFF) rule summary, a link to Oklahoma State Cooperative Extension's (OSU) poultry waste management education website about litter application (<a href="https://extension.okstate.edu/programs/poultry-waste-management-education.html">https://extension.okstate.edu/programs/poultry-waste-management-education.html</a>).
- 2. Although conservation districts can provide assistance, buyers are responsible for finding the litter source and arranging for transport, payment for hauling, etc. One source of qualified haulers and brokers is the Oklahoma Litter Market, (<a href="http://oces.okstate.edu/poultrywaste/links/12-8-15%20Litter%20Market%20Guide.pdf">http://oces.okstate.edu/poultrywaste/links/12-8-15%20Litter%20Market%20Guide.pdf</a>) maintained by OSU.

- 3. Only litter applied by licensed applicators is approved for the program; therefore the applicant must have an applicators license before receiving litter.
- 4. Once litter has been applied by a licensed applicator, districts will submit the completed Litter Transfer Documentation Form and accompanying documentation to Ed Crall for approval of payment.
- 5. Buyers and Growers will each be reimbursed for their participation at approved rates through their respective conservation districts and each district will also be reimbursed for their assistance with the program.



#### POULTRY WASTE APPLICATION IN OKLAHOMA

## A Brief Summary of a Portion of the Requirements Pertaining to the Land Application of Poultry Waste

- A Poultry Waste Applicator License is required.
- Soil samples, poultry waste samples, and laboratory analyses of each for soil pH and plant available nutrients including at least nitrogen, phosphorus and potassium, plus poultry waste nutrient concentrations and moisture. Required every three years in non-nutrient limited watersheds. NOTE: By law, the person furnishing the poultry waste is required to give a poultry waste laboratory analyses report to the buyer.
- Stored poultry waste shall be isolated from outside surface drainage by ditches, dikes, berms, terraces, or other structures.
- Poultry waste shall not be stored without adequate protection from rainfall and runoff.
- Records shall be maintained of all poultry waste applied on lands and an annual report is required to be submitted to ODAFF.
- Poultry waste land application must occur at agronomic rates and shall not be made at any rate which exceeds the most current USDA-NRCS Waste Utilization Standards.
- Poultry waste cannot be land applied when the ground is saturated, frozen, snow covered, or during rainfall events.
- Edge of field, grassed strips shall separate water courses from runoff.
- All certified poultry waste applicators are required to obtain the official Oklahoma Cooperative Extension Service poultry education (9 hours within the first year and 3 hours each year thereafter). Refer to <a href="www.poultrywaste.okstate.edu">www.poultrywaste.okstate.edu</a> for dates and more information.

#### **Illinois River Riparian Easement Program**

- Riparian exclusion payments have been made with the help of the three participating districts. The projected totals include a total of 31 landowners for the year 2021 totaling 1,498 acres and a total payout of \$88,710.30. These agreements are spread across three counties as follows:


