CALL TO ORDER

The Oklahoma Conservation Commission met Monday, February 07, 2022, in the Agriculture Building located at 2800 N. Lincoln Boulevard in Oklahoma City, Oklahoma. The meeting was called to order at 9:30 a.m. by Chair Scotty Herriman. He stated this was a regular scheduled meeting held in accordance with the Open Meeting Law, Title 25, Oklahoma Statutes, Sections 301 and following as amended. Ms. Bond worked with the Soil Health Coordinator to create educational documents, presentations, and displays that can serve as templates for training. The educational tools will be a good resource for learning about sustainable land uses and pollution prevention.

CONSERVATION PARTNERSHIP REPORTS

Oklahoma Department of Agriculture, Food and Forestry: – No report available.

USDA-Natural Resources Conservation Service: Jamey Wood, State Conservationist, reported on the following items-

- Staffing updates – Jamey Wood is serving as Acting State Conservationist. Mr. Wood will be serving in his 5th week this upcoming Friday. The duration for Mr. Wood to serve as Acting State Conservationist is 4 months; Jim Ellis, Soil Conservation Tech in Stillwater retired in January 2022; Amanda Duvall resigned as Soil Conservationist on February 4, 2022; April Burns starts detail at Headquarters next Monday working on watershed rehab; Natural Resources Conservation Service has required additional direct hire authority and still waiting on approval. Natural Resources Conservation Service plans to hire several employees over the next few years.

- Customer Service Training – Mr. Wood noted it was important to give good customer service to customers. Natural Resources Conservation Service is working on obligating a contract to hire a trainer. Training will be virtual; available to anyone in partnership. Training should take place in the next few months and twelve sessions of training will be available.

- Program Equipment Construction Incentive Contract – Focus is on Soil Health. Looking at five practices: Conservation Crop Rotation, Residue and Tillage Management No Till, Cover Crop, Residue and Tillage Management Reduced Till and Nutrient Management.

- Watershed Rehab Projects – Cottonwood 54, waiting on vegetation; Fourche Maline 7M, hoping to start construction soon; Upper Black Bear, waiting on land rights to start construction; Sallisaw 26, in planning; Scraper Hollow 2, in planning; Okfuskee Tribbs, new dam in planning;

City of Lawton is working with Natural Resources Conservation Service to do a Preliminary Investigation Feasibility Report.

Oklahoma Association of Conservation Districts: Sarah Blaney, OACD Executive Director, reported on the following items-

- OACD State Meeting – Lieutenant Governor Matt Pinnell will give welcome; Secretary of Agriculture will speak during the Monday luncheon. Katie Blunk, Woods County Conservation District director, will be recognized at the banquet as the Leopold winner.
- Legislative banquet – Invitations have been sent to the legislature and special guests. OACD is encouraging districts to follow up with an invitation of their own.
- National Association of Conservation Districts Meeting – Planning on 6 CARE Champions to participate.
- Conservation Day at the Capitol – Event will take place on April 7, 2022. Breakfast will be provided for the legislative committee by invitation only.
- Leadership Class – Eighteen district directors have been selected to participate with the first session starting on April 18 – 19, 2022.
- Estate Planning Workshop – Oklahoma Association of Conservation Districts planned and hosted an estate planning workshop in conjunction with Oklahoma State University.
- Notices – Received notice on Partnership of Equity Agreement with United States Department of Agriculture. Oklahoma Association of Conservation Districts will receive additional funding which will be allocated to Conservation Districts.
- National Association of Conservation Districts Legislative Fly-in will again be held virtually this year. OACD is preparing to host legislative meetings in the congressional district with district director constituents.
- National Land and Range Judging – Meeting with Oklahoma County Conservation District and Partners on Thursday.

OKLAHOMA CONSERVATION COMMISSION MEMBERS

Mr. Herald – got moisture; received between 6-8 inches of snow.

Mr. Herriman – recognized Bryan Painter for being inducted into the Journalism Hall of Fame. Mr. Painter attributed his success to his parents.

Mr. Crawley – nothing to report.

Mr. Campbell – looking forward to attending the National Association of Conservation District Meetings.

Mr. Forst – nothing to report.

OKLAHOMA CONSERVATION COMMISSION STAFF

Executive Director: Mr. Lam reported the following items:

Mr. Lam stated that the Governor's office was releasing the State of State address today. Mr. Lam is working with Ms. Stewart and Mr. Toole to keep the Abandoned Mine Land Reclamation Program in place at the Oklahoma Conservation Commission. Mr. Lam met with staff from the Oklahoma State Attorney General's office to discuss concerns about the Abandoned

Mine Land Program. Mr. Lam stated the Oklahoma Conservation Commission is working on nutrient management planning with a working group. Mr. Lam participated in a meet and greet in Garvin County upstream flood control landowners; Dan Sebert, National Watershed Coalition executive director, participated and spoke at the meeting. Mr. Lam also participated at the Prescribed Burning event in Murray County. Mr. Lam is helping plan for a Regenerative Agriculture Workshop in Edmond.

Water Quality Program: Shanon Phillips, OCC Water Quality Division Director, Ms. Phillips mentioned that there was a report in the packet. Ms. Phillips stated that Water Quality has been busy with program planning and end of year reporting. The soil health team met to do some strategic planning. Demand for soil health programs has come close to overwhelming soil health's abilities and this will not only help the new program director envision goals, but will help the team in setting priorities and supporting partnerships. Applications for the director position are under review and interviews will soon take place. Thanks to Clancy for letting Water Quality use the January District Training program to talk about poultry litter transport. Great questions were asked from districts that allowed for improvements to the process including a requirement for boards to approve participation in the program like the State Cost-Share Program. Since the training, multiple districts have reached out with questions and requests for customized flyers to advertise the program. Water Quality is working with the Grand River Dam Authority to schedule multiple public meetings in February and March with poultry growers. Information will be given about the Neighbors Helping Neighbors Project and the Litter Transfer Program. Water Quality is pleased to announce a new Water Quality Monitoring Program person Jake Swanson, has started part-time this month. Jake is completing a master's degree in SF Austin and will move to full time in May.

Office of Geographic Information and Technical Services: Mike Sharp, Director, stated that there was a written report in the packet and would be happy to answer any questions. Mr. Sharp recognized Ms. Willoughby for efforts on preparing for GIS Day at the Capitol which takes place on March 9, 2022. Mr. Sharp stated that a proposal has been filed for American Rescue Plan Act funding of \$10.4 million for new aerial photography and LiDAR. Mr. Sharp also noted that Office of Geographic Information and Technical Services would like to acquire new photography for 2023 and 2026. Mr. Sharp mentioned hopes of getting LiDAR data. Mr. Lam and Mr. Sharpe are meeting with Senator Daniels on February 09, 2022. The discussion will be about suggested changes in current Geographic Information Council statutes.

Abandoned Mine Lands Reclamation: Robert Toole, Director, stated that a written report was in the Commissioner's packet. Mr. Toole informed the Commissioners of a new initiative launched by Abandoned Mine Lands staff called Hardrock Abandoned Mine Land Reclamation. The Infrastructure Investment and Jobs Act of 2021, signed into law November 15, 2021, authorizes \$1.5 billion to be appropriated to states for Hardrock Abandoned Mine Land Reclamation. Hardrock is anything non-coal that has been mined. With that opportunity on the horizon, Abandoned Mine Lands staff has been directed to focus staff energy and expertise on Hardrock AML Reclamation. Janet Stewart is developing legislation to position Oklahoma Conservation Commission to administer a Hardrock AML Reclamation Program. Mike Sharp has been configuring OKMaps to identify Hardrock mining and relevant parameters that need to be captured for inventory. Dianne Ireton and Kendall Brookins have been developing the database

for the inventory. A workshop is scheduled for February 8, 2022, for a hands-on training of field staff including: Tracy Reeder, Valerie Rogers, and Trampas Tripp to begin inventory efforts using OKMaps. Over 3,700 potential sites have been identified that span statewide in every Conservation District. Conservation Districts will eventually be engaged to identify unknown sites and establish priorities for district of responsibility.

Conservation Programs: Tammy Sawatzky, Director of Conservation Programs reported on the following items:

- Held site showing in Logan County to remove a log jam on Deer Creek; currently getting bids.
- Watershed technicians and aides made up of six-man crew that cleared four sites in Johnston County; in doing so, built rapport with landowners.
- Watershed work in Seminole County has been postponed due to weather.
- Sending a watershed maintenance team out once a month to assist districts that have made a requests.
- Several counties have submitted requests for operation and management work; Districts are inquiring to see what funding is available.

Assistant Director: Lisa Knauf Owen reported on the following items:

Ms. Owen stated due to inclement weather plans to travel to Topeka, KS for the State Association of Kansas Watersheds meeting was cancelled. Instead, Ms. Owen participated virtually in the Association of Kansas Watershed meeting. Ms. Green has been training districts on 2021 tax preparation over Teams; also, training new hires in Kay Co., Cotton Co., and Konawa Co. Ms. Owen gave a presentation at the North Fork of the Red River feral swine outreach meeting and participated at the prescribed burning meeting in Murray County.

The next regular meeting of the Oklahoma Conservation Commission is scheduled to be held on Monday, March 07, 2022, at the Oklahoma Department of Agriculture Building, 2800 N. Lincoln Blvd., Oklahoma City, Oklahoma at 9:30 a.m.

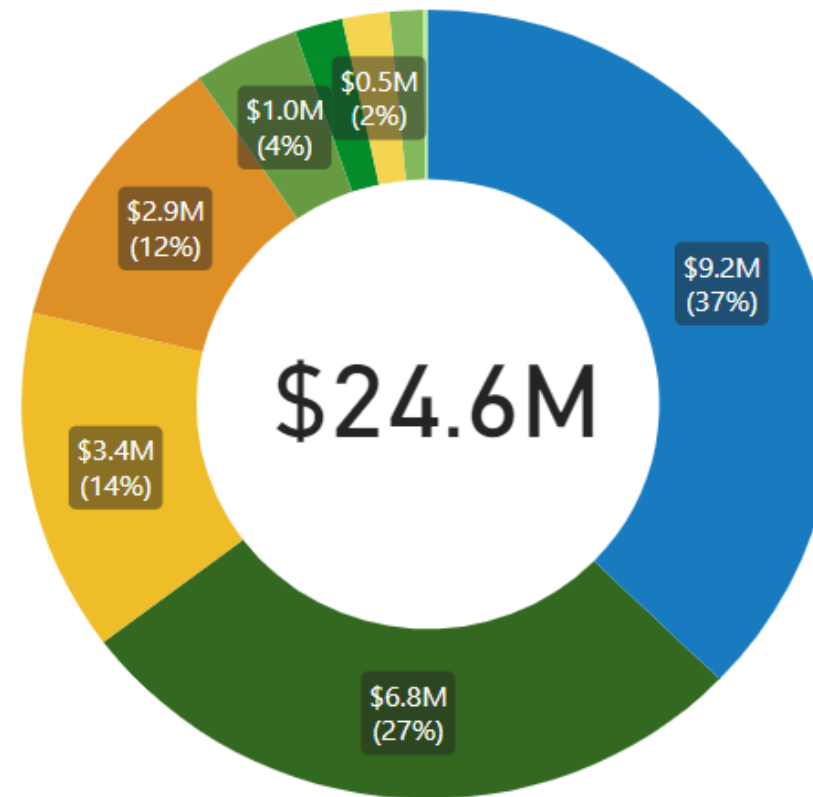

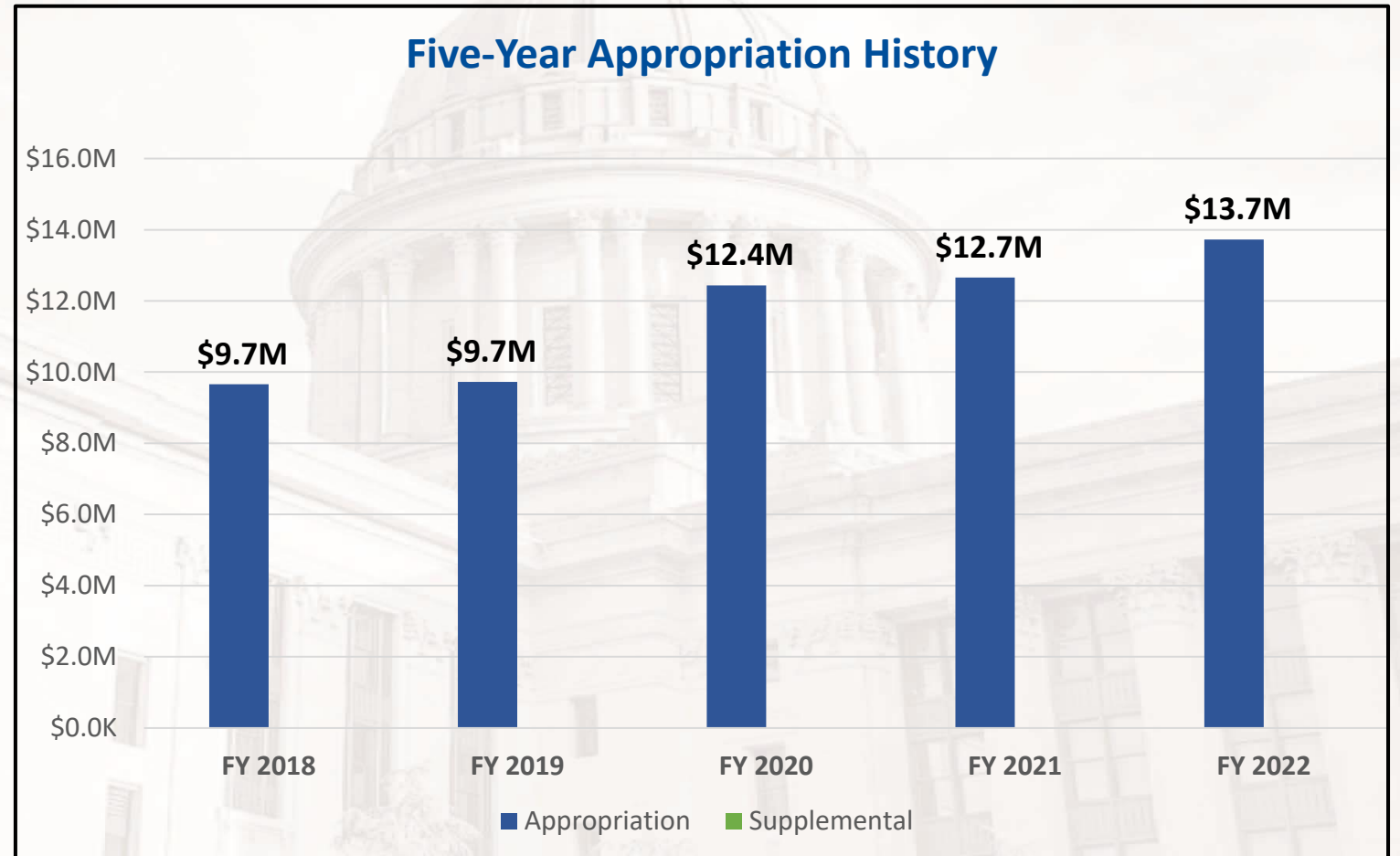

Abandoned Mine Land (AML) Reclamation Program | \$4,165,012

Abandoned Mine Land (AML) protects lives, repairs scarred land, and improves the environment. The primary objective is to protect the public from hazards resulting from past coal mining practices by eliminating risks through the reclamation of abandoned surface and underground coal mine sites that pose the highest threat to the public's health, safety, and general welfare. To accomplish the mission of the AML program, abandoned mine sites must be identified, inventoried, assessed, prioritized, right-of-entry acquired, plans developed, surveys performed, design completed, construction contracted, construction performed with AML inspection, vegetation established, and maintenance monitored for at least two years. AML also responds to emergencies created by sudden occurrences involving abandoned coal mines when a public health or safety issue requires immediate action.

Conservation Programs (Watershed Ops and Maintenance) | \$12,461,731

Watershed Ops and Maintenance provides technical and financial assistance to conservation districts in support of the districts' responsibilities to operate and maintain 2,107 upstream flood control dams. These dams represent a \$2 billion public infrastructure that provides \$91 million in state benefits annually. The Watershed Program works in cooperation with the Natural Resources Conservation Service and conservation districts, to provide technical and financial assistance to modify high hazard dams to ensure they meet state dam safety criteria for reducing the risk of loss of life and improving public safety. The Locally Led Conservation Cost-Share Program provides funds to conservation districts to assist landowners to install conservation practices on the land to reduce soil erosion and improve water quality.



Program Details

Field Services | \$9,650,503

Field services funding is provided to the state's 84 conservation districts for personnel and operations to support the administration of their duties pursuant to the Conservation District Act, Title 27A, and Chapter 3 of the Oklahoma statutes. District Services provides tools, training, and technical assistance to conservation district boards and employees on public official governance, personnel management, and financial management in compliance with state laws, rules, regulation, and policy.

GIS/IDS Data Processing | \$222,957

The Office of Geographic Information (OGI) provides Geographic Information Systems (GIS) and Information Technology (IT) support to Commission and Conservation District staff. Within this program the Office of Geographic Information manages the state's geospatial data clearinghouse, OKMaps, which provides authoritative geographic information to the public, government agencies, businesses and educational institutions inside and outside Oklahoma

Water Quality / Wetlands Program | \$8,542,974

Water Quality and Wetlands program is responsible for identifying state waters impaired by nonpoint source pollution and then prioritizing and implementing projects to reduce pollutants by measurable amounts and improving water quality in effort to remove streams from the state's List of Impaired Waters (Clean Water Act Section 303(d)List). The agency is responsible for preparing and updating the state's wetlands conservation plan and coordinating the state's Wetland's Working Group to conserve, enhance, and restore the quantity and biological diversity of wetlands in Oklahoma. As federal and state funds are available, OCC provides management of funds on a watershed basis to assist landowners with installing conservation practices to address water quality problems. The Soil Health Education Program, in cooperation with conservation districts and other partners, educates agricultural producers and other citizens about soil health and the potential for regenerative farming. In cooperation with conservation districts and other partners, this agency division educates citizens across the state about water quality and nonpoint source pollution and trains citizen volunteers to collect data that can be used to supplement the state's data collection capabilities.



AGENCY ACCOMPLISHMENTS

- Completed 2,107 dam safety inspections, performed maintenance on 639 dams, completed remedial repairs on 5 dams, completed flood damage repairs on 5 dams and responded to more than 19,500 Okie One-Call tickets to prevent damage.
- Delivered the locally led cost-share program to 833 land managers, leveraging \$1.56 million in state funds against \$1.27 million in private funds to apply best management practices to improve soil health and water quality. Assisted USDA-National Resource Conservation Services in delivery of \$37.4 million of federal conservation assistance to Oklahoma landowners through Farm Bill Programs.
- Delisted 6 stream segments from the impaired streams list. Assessed the health of streams and rivers by maintaining 300 monitoring sites and collecting over 1000 water samples.

- Soil Health Team will mentor at least 50 people; participate in at least 15 field days; and support soil health conservation on at least 1,000 new acres each year.
- Restore \$3 million of federal funding for the state AML program; reclaim 2 sites and 107 acres.

Illinois River Riparian Easement Program

- Riparian exclusion payments have been made with the help of the three participating districts. The projected totals include a total of 31 landowners for the year 2021 totaling 1,498 acres and a total payout of \$88,710.30. These agreements are spread across three counties as follows:
 - **Cherokee County** – Payments have been made to 4 landowners for a total of 328.3 acres of riparian exclusion and a total payment of \$20,682.90.
 - **Delaware County** – Payments have been made to 3 landowners for a total of 75.9 acres of riparian exclusion and a total payout of \$5,009.40.
 - **Adair County** – Payments have been made to 24 landowners for a total of 1,050.8 acres and a total payout of \$63,018.
