- e. General Mills Corporation (OCC-667) to support soil health education and conservation in the north central Oklahoma wheat production area serving Enid, OK. **Amendment 1** continues the agreement.
  - f. Oklahoma Water Resources Center at Oklahoma State University (OCC-610) to provide funds for the development of a customized version of a Hydrologic and Water Quality System (HAWQS) for Oklahoma (OK-HAWQS). The final customized version of this application will facilitate ready production and parameterization of calibrated Soil and Water Assessment Tool (SWAT) model for any party conducting critical watershed assessments across the state. **Amendment 5:** Extends time and adds funds to the agreement.
  - g. Oklahoma State University, Division of Agricultural Sciences and Natural Resources (OCC-712) OCC will provide funding in support of the Master Irrigator Program which gives irrigators the knowledge, tools and assistance they need to adopt advanced irrigation technologies and strategies which increase water use efficiency, support achievement of Water for 2060 goals and sustain the state's precious freshwater supplies, while improving farm income and sustainability. **Amendment 2:** no cost time extension.
  - h. Oklahoma Secretary of Energy and Environment (OCC-777) to create a formal mechanism to provide EPA wetland resources for the Commission's Wetlands Program with statewide application of the restorable wetlands identification protocol and wetland program plan update. **Amendment 2:** no cost time extension.
  - i. Oklahoma Secretary of Energy and Environment (OCC-778) to create a formal mechanism to provide EPA wetland resources for OCC's Wetlands Program to improve wetland maps for floodplains of the Canadian and Arkansas Rivers and associated tributaries. **Amendment 3:** no cost time extension.

### CALL TO ORDER

The Oklahoma Conservation Commission met Monday, November 7, 2022, in the Agriculture Building located at 2800 N. Lincoln Blvd in Oklahoma. The meeting was called to order at 9:30 a.m. by Chair Gary Crawley. He stated this was a scheduled regular meeting held in accordance with the Open Meeting Law, Title 25, Oklahoma Statutes, Sections 301 and following as amended. ## **MINUTES OF PREVIOUS REGULAR MEETING**

A motion was made by Mr. Forst and seconded by Mr. Priess to approve the minutes of the October 3, 2022 Commission meeting as written. Those voting aye were: Herriman, Forst, Crawley, Herald and Priess. Nay votes: none. Motion carried.

## **CLAIMS/FINANCIAL STATEMENT**

Commissioners reviewed the claims register, p-card statement, revenue summary and allotment budget / available cash report as provided by Ms. Parsley in Exhibit #2. She stated that claims were processed totally \$2.52 million during a 38-day period. Ms. Parsley introduced the Conservation Commission's new APO/CPO, Pat Foy-Binkley. A motion was made by Mr. Forst and seconded by Mr. Herriman to approve the financial reports as presented. Those voting aye were: Herriman, Forst, Crawley, Herald and Priess. Nay votes: none. ## **PRESENTATION OF AGREEMENTS**

Ms. Owen presented two new agreements for approval listed as item "a-b" on Exhibit #2. The first agreement would provide office space for the shared Water Quality Liaison position on OSU Campus in Stillwater and the second is to obtain auditing services for FY22 EPA 319 expenditures. Ms. Owen recommended approval of these agreements. After discussion, a motion was made by Mr. Herriman and seconded by Mr. Priess for approval of the new agreements. Those voting aye were; Herriman, Forst, Crawley, Herald and Priess. Nay votes: none. Motion carried.

Ms. Owen presented one amended agreement for approval listed as item "c" on Exhibit #2. Ms. Owen noted that the amendment reduces the amount of the agreement as much of the work completed was done by agency staff. The end date for this agreement is December 31, 2022. Ms. Owen recommended approval of the amended agreement. After discussion, a motion was made by Mr. Herald and seconded by Mr. Forst for approval of the amended agreement as presented. Those voting aye were: Herriman, Forst, Crawley, Herald and Priess. Nay votes: none. Motion carried.

### **REVISED EMERGENCY DROUGHT COST-SHARE PROGRAM GUIDELINES**

Mr. Lam reviewed revisions made to the Emergency Drought Cost-Share Program Guidelines with Commissioners as presented in Exhibit #6. The guidelines were updated to allow for changes based on the Drought Commission's recommendations. After discussion, a motion was made by Mr. Priess and seconded by Mr. Herald to ratify the revisions to the Emergency Drought Cost-Share Guidelines as presented. Those voting aye were: Herriman, Forst, Crawley, Herald and Priess. Nay votes: none. Motion carried.

### **CO-SPONSOR MEETINGS**

Two meetings were presented by Mr. Lam for sponsorship consideration. The first was the Governor's Water Conference on December 7-8, 2022. The second being the Oklahoma Association of Conservation Districts' Annual State Meeting in February 26-28, 2023. After discussion, a motion was made by Mr. Forst and seconded by Mr. Herriman to sponsor both meetings. Those voting aye were: Herriman, Forst, Crawley, Herald and Priess. Nay votes: none. ### **CONSERVATION PARTNERSHIP REPORTS**

*Oklahoma Department of Agriculture, Food and Forestry:* Audrey Ochsner introduced Lee Benson to the Commissioners. Lee Benson, who is the new PIO for the department. She reported that the Ag Commission held their traveling meeting this past month stopping in Hydro, Hobart, and Altus. The ODAFF will be hosting a Fall Festival on Wednesday, November 9, 2022 prior to the Emergency Drought Commission Meeting at 3:00 p.m.

*USDA-Natural Resources Conservation Service:* Amanda Mathis, Acting State Conservationist, noted that the agency's priorities for FY23 remain the same: 1. Climate Smart Ag and Forestry, 2. Equity in Program Delivery, 3. Urban Conservation.

Ms. Mathis reported that delivery of program funding made available through the Inflation Reduction Act will begin in FY23. She stated that this is not a new program but will work through existing programs. She indicated that this is an opportunity for NRCS to be innovative, think creatively, use program flexibilities and expand demand and partnerships in order to deliver these funds. Ms. Mathis noted the FY23 application deadlines for each of the programs. Ms. Mathis mentioned there are two new tribal conservation districts; Choctaw and Comanche Nation. She also reported on numerous personnel actions for October 2022 and indicated that interviews had been completed for the State Conservationist position, but the selection was yet to be announced.

*Oklahoma Association of Conservation Districts:* Sarah Blaney, presented upcoming outreach training for Tulsa area and OKC area with limited seating, 30 seat limit for each area. She also presented the land judging registration to be sent out. Registration will be an online

process this year. OACD is attending the Inter-Tribal Agricultural Council Meeting in Las Vegas this December. There will be a Farmer Veteran Coalition booth at the Kansas Association of Conservation Districts meeting. The Small Farmers Conference is on November 18-19, 2022, in Wewoka, OK.

Ms. Blaney stated she is proud to introduce the Eco-Harvest market program, an innovative ecosystem services solution for agriculture. Eco-Harvest rewards producers for beneficial environmental outcomes from regenerative agriculture – including increased soil carbon, reduced greenhouse gases, and improved water quality. Ms. Blaney also noted that in June 2022, General Mills Inc (GMI) and Ecosystem Services Market Consortium (ESMC) announced the development of a multi-year roadmap to meet General Mills’ supply chain carbon and greenhouse gas (GHG) and regenerative agriculture commitments through ESMC’s Eco-Harvest market program. Eco-Harvest, launched in May 2022 after more than three years of pilot testing and refinement with agricultural supply chain and value chain partners, is an innovative ecosystem services market program that pays farmers for beneficial environmental outcomes from regenerative agriculture. Eco-Harvest meets food and beverage sector annual Scope 3 reporting needs for quantified, verified soil carbon removals and reduced GHG emissions from agricultural production within their supply chains.

## **STATUS REPORTS**

### **OKLAHOMA CONSERVATION COMMISSION MEMBERS**

Mr. Priess –Thankful for all participants in the Area 2. Payne County was awarded Outstanding District.

Mr. Forst –Nothing to report

Mr. Crawley – area received 3-4” of rain and greening up.

Mr. Herriman – Area received 1.4” of rain and wheat growth developing.

Mr. Herald- Area received the first snow of the year.

### **OKLAHOMA CONSERVATION COMMISSION STAFF**

*Executive Director: Trey Lam.* Mr. Lam reported that the agency held a full staff meeting this past month and have completed the hiring within Finance Department. He also introduced Bert Bitseedy as the Agency’s new Administrative Assistant and welcomed her to her first Commission meeting.

*Water Quality Program: Shanon Phillips, OCC Water Quality Division Director,* Ms. Phillips stated that there was a report in the packet, and she would be happy to answer any questions. She states that she has just submitted the 100<sup>th</sup> success story and her goal at the end of the year is to submit over 100 success stories.

*Office of Geographic Information and Technical Services: Mike Sharp, Director,* Dr. Sharp stated that there was a report in the packet, and he would be happy to answer any questions.

*Abandoned Mine Lands Reclamation: Trampas Tripp, Director.* Mr. Tripp stated that there was a report in the packet, and he would be happy to answer any questions. Reported that the grant for unpaved roads per county was approved. AML phase II approved signed \$866,000 in repair. Two projects were completed and continue updating inventory records. Non coal inventory, requesting each district to report any abandoning mines, Mike Sharp will assist in putting together the maps.

*District Services: Clancy Green, Director,* Ms. Green reported that directors from the Little

River Conservation District were affected by the tornados that went through Idabel.

*Conservation Programs:* Tammy Sawatzky, Director. Ms. Sawatzky stated that there was a report in the packet, and she would be happy to answer any questions. She also stated that the drought assistance program will become well know and is gaining more applicants.

*Assistant Director:* Lisa Knauf Owen. Ms. Owen announced Rebecca Bond has completed the requirements and graduated from the Certified Manager Program. Clancy Green will begin the CPM program in January.

## PURPOSE

Governor Kevin Stitt Declared the Following:

Due to the current, and persistent, emergency drought conditions in all 77 Counties of Oklahoma, I hereby invoke the provisions of Oklahoma law regarding the use of the Emergency Drought Relief Fund.

Executive Order 2022-23 appears on pages 10-11.

The Oklahoma Conservation Commission (Commission) herein establishes the complete list and description of the Emergency Drought Cost-Share Program policies and practices approved for use by all 84 of Oklahoma's Conservation Districts. Cost-share average costs (unit cost) are based on Oklahoma Natural Resources Conservation Service (NRCS) data and local conservation district data.

Any exceptions from these established Emergency Drought Cost-Share Program policies and guidelines shall be approved by the Commission.

## ALLOCATION OF FUNDS

### Emergency Drought Cost-Share Program

The Emergency Drought Commission (Drought Commission) allocates \$3,000,000 from the Emergency Drought Relief Fund to the Commission for the purposes of providing cost-share payments to eligible participants for implementing approved cost-share emergency drought practices.

**\*As of October 17, 2022 the Emergency Drought Commission added an additional \$5,000,000 to the Emergency Drought Cost-Share Program.**

**\*As of November 9, 2022, the Emergency Drought Commission added an additional \$12,000,000 to the Emergency Drought Cost-Share Program. Additional program changes from this meeting are outlined in Addendum 1.**

### Conservation District Allocation

The Commission allocates \$2,541,900 of emergency drought funds to conservation districts. The amount of funds allocated to each conservation district can be found on page 7. Each county will be allocated \$33,000. Allocations for conservation districts not on county boundaries will be based on the percentage of county acres that fall within the conservation district boundary.

**\*As of October 17, 2022 each county will be allocated an additional \$64,935 because of the additional \$5,000,000 put into the Emergency Drought Cost-Share Program.**

**\*\*As of November 9, 2022 each county will be allocated an additional \$155,844 because of the additional \$12,000,000 put into the Emergency Drought Cost-Share Program. Additional program changes from this meeting are outlined in Addendum 1.**

These funds will become available to conservation districts on October 3, 2022. The Commission will hold \$458,100 in reserve and make it available to conservation districts who demonstrate the greatest need. Requests for an additional allocation must be submitted to the Commission no later than December 5, 2022. Your district will be notified December 7-12, 2022, if your request for an additional allocation is approved.

## **POLICIES**

### Program Year

Program Year ED2 begins on October 3, 2022 and ends on December 2, 2023. All Performance and Maintenance Agreements must be completed, and cost-share payments disbursed by December 2, 2023. The Commission will not process claims received after December 2, 2023.

### Allocation Period

The allocation period shall start October 3, 2022, and end December 2, 2022. Funds allocated to conservation districts and not obligated by December 2, 2022 will be withdrawn and made available for reallocation by the Commission. Funds become obligated to a participant after approval of the application by the conservation district board and a Performance and Maintenance Agreement has been signed and dated by the board and the participant.

### Eligibility Requirements

Applicants must be a district cooperator.

Applicants must be experiencing drought conditions.

Applicants must agree to maintain the conservation practice for the expected life specified by the conservation district.

Applicants that lease the land must submit a landowner consent form with their application. The landowner must agree to continue maintenance of the conservation practice for the expected life specified by the conservation district if the land lease agreement is canceled.

Conservation Commissioners, Conservation Commission staff, conservation district employees or the spouses of any of these people shall not be eligible to participate in the Emergency Drought Cost-Share Program.

Conservation district directors are eligible to participate in the Emergency Drought Cost-Share Program. Due to the limited amount of funds available for Program Year ED2 individual directors should consider public perception when making their decision to participate in the Program. If the conservation district board decides that members can apply and members choose to apply for Program Year ED2 the guidelines below must be followed.

1. Individual conservation district board members applying cannot discuss any element of the Emergency Drought Cost-Share Program including but not limited to practices, rates, average costs, selection criteria, application approval/disapprovals, cost-share payments, and extensions.

2. Individual conservation district board members applying for the Emergency Drought Cost Share Program must abstain from voting on all elements of the Program.
3. Individual conservation district board members cannot use their position as a board member to improve or elevate their individual chances of becoming successful applicant.

Authorized District Representative(s)

The conservation district board must designate at least one authorized district representative. This person can sign all forms. The authorized district representative must be a conservation district board member. It cannot be a district employee.

Authorized Technical Representative(s)

The conservation district board must designate at least one NRCS technical representative and at least one district technical representative. Conservation district directors and employees can serve as the district technical representative. District directors participating in the program cannot serve as the district technical representative.

The NRCS designated technical representative will:

- develop conservation plans,
- design and layout practices,
- certify installed practices meet NRCS approved standards and specifications.

The district technical representative will:

- certify applicant’s eligibility,
- certify installed practices meet Commission approved standards and specifications.

**NOTICE: As of October 17<sup>th</sup>, 2022 it is no longer required to certify drought conditions for any practices in the Emergency Drought Cost-Share Program. The form has been removed from the website.**

**NOTICE: As of November 9<sup>th</sup>, 2022 it is no longer required for participant to have NRCS Conservation Plans to complete their practice. Additional program changes from this meeting are outlined in Addendum 1.**

NRCS and district technical representatives will be required to sign the Certification of Completion and Acceptance form.

**NOTICE: As of October 17<sup>th</sup>, 2022 any pond cleanouts or pasture taps completed after June 11<sup>th</sup>, 2022 will be eligible for the Emergency Drought Cost-Share Program. These “retroactive” applications will not require a performance agreement but will require completion of a special certification of completion and acceptance form.**

**NOTICE: As of November 9<sup>th</sup>, 2022, ALL practices on the above list that were completed after June 11<sup>th</sup> are now retroactive. These “retroactive” applications will not require a performance agreement but will require completion of a special certification of completion and acceptance form. Additional program changes from this meeting are outlined in Addendum 1.**

Each district board may select any of the eligible conservation practices for inclusion in the district’s local guidelines. Conservation practices shall be implemented according to applicable NRCS, Commission or rural water district standards and specifications.

#### Average Cost

State average cost (unit cost) for eligible conservation practices is based on Oklahoma NRCS data and local conservation district data. These costs are located on pages 8-9 of this document.

#### Maximum Cost-Share Payment

The Commission sets the maximum cost-share payment amount per participant at \$7,500. The conservation district board cannot change the maximum cost-share payment.

#### Maximum Cost-Share Rate

The maximum cost-share rate for all conservation practices is 80%. Each conservation district board may choose to establish a cost-share rate less than 80%.

#### Application Process

Conservation districts should announce the availability of funds throughout the district. Potential applicants must return completed applications to the district prior to the end of the district’s application period. Applicants that lease the land must submit a landowner consent form with their application. Each applicant is limited to one application. Multiple practices can be applied for on one application.

Conservation district technical representatives must complete a Certification of Drought Condition and Applicant Eligibility form for each application received.

#### Approval Process

Conservation districts must establish local program priorities and an application ranking system that will be used to make funding decisions. Applications must be approved during an official conservation district board meeting. Board meeting minutes must include a copy of the approved program priorities and application ranking system, list of approved applications showing the applicant’s name, practice, and allocated amount.

Conservation districts that have more qualified applications than available funds may choose to approve those applications as alternates on the condition that funding becomes available. Work cannot begin until notified by the conservation district that funds are available. All approved alternates must understand that there is no guarantee that funds will become available during the program year.

Completion Dates

The Commission establishes February 2, 2023 as the completion date for installation of all conservation practices. This is an emergency program that requires swift action. Conservation districts must enforce the established completion date for approved applicants. The participant should make every effort to complete approved practices by February 2, 2023. Participants that have not started, are not under construction, or have not completed implementation of practices by February 2, 2023 can be canceled and funds reallocate to an approved alternate. When mitigating circumstances influence a participant’s ability to complete implementation, they can submit a written request to the district board for a 30-day extension.

Execution of Performance and Maintenance Agreement

After an applicant has been notified they have been approved for CSP funds, the applicant and conservation district must execute a Performance and Maintenance Agreement. An agreement number following the Commission approved format must be assigned to each agreement. Example agreement number – 03-ED2-001

- 03 - conservation district number
- ED2 - program year number
- 001 – applicant number assigned by the district

**NOTICE: For reporting purposes, applicants with retroactive practice will require an identifying agreement number without a physical agreement.**

All Program Year ED2 Performance and Maintenance Agreements must be signed and dated by the district board and participant on or before December 2, 2022. All Program Year ED2 agreements must be completed, and payments made to the producer on or before December 2, 2023. Installation of conservation practices cannot begin until an effective agreement is in place. An agreement becomes effective on the last date of signature. Each participant should have only one agreement.

Approved alternates must also sign a Performance and Maintenance Agreement on or before December 2, 2022.

**ADMINISTRATIVE GUIDELINES**

District Reporting and Accounting

Conservation districts shall conduct the following reporting and accounting procedures:

1. Maintain a Cost Share Program Allocation Report in electronic format. The report should include data for all conservation district board approved Performance and Maintenance Agreements. Agreement approved as alternates must be labeled as 'alternate'. The report should include the following:
  - conservation district name
  - applicant's name
  - agreement number
  - expected completion date
  - obligated amount
  - agreement effective date
2. Submit the Cost Share Program Allocation Report to the Commission for review on December 5, 2022. This report will be used to make an additional allocation of funds. Districts will be notified December 7-12, 2022, if they were approved for an additional allocation.
3. Assemble case files for each approved applicant

#### Commission Reporting and Accounting

The Commission shall conduct the following reporting and accounting procedures:

1. Receive and review Cost Share Program Allocation Reports from conservation districts.
2. December 7-12, 2022 reallocate to conservation districts with unfunded approved alternates unobligated emergency drought funds returned at the end of the allocation period.

## Addendum 1

### 1.1 Funding:

- Additional \$12 million added to the Emergency Drought Cost-Share Program
- Each county will receive \$155,844

### 1.2 Conservation Practices

- All eligible conservation practices completed on June 11, 2022 or after are now eligible.
- Participants are no longer required to follow NRCS specifications.
- Implementation of all practices do not require district or NRCS staff certification.
- Conservation plans are no longer required for any practice.
- Implementation of all practices will be self-certified by the participant. (*new form*)

### 1.3 Taking Applications

- All districts are required to immediately reopen your application period and remain open until COB *November 28, 2022*.
- All districts must accept applications for all practices during this application period.
- All districts are required to advertise this new application period.
- Individuals must be able to apply in person, email, or snail mail. Districts cannot require in person application only.
- In cases where districts have taken names and telephone numbers of individuals interested in the drought program you must contact them and give them an opportunity to complete an application.
- Individuals that have already applied cannot reapply during this new application period unless they withdraw their original application. For example: they applied for a pond cleanout, it has rained and they have water in their pond. The pond cleanout application can be withdrawn and they can apply for a different practice. One application per person.
- At this point in the program districts should have already set their cost-share rate(s), you cannot go back and change them.

### 1.4 Applications

- Applications that have previously been ranked and approved for funding do not require a performance agreement or consultation with NRCS prior to beginning implementation.
- Applications that have been ranked and approved as alternates can be funded with the additional allocation your district received today.
- New applications received during this new application period will not be ranked using your districts ranking system. Approval for funding must be completed in a district board meeting using an online random number generator. Just Google "random number generator" and you will find many options to pick from.
- Performance agreements are no longer needed.
- Waivers to start are no longer needed.

### 1.5 Claims

- Average costs will not be used as part of the payment calculation.
- Cost-share payments will be the lesser of the participant's actual cost to install the practice multiplied by your district's approved cost-share rate or the maximum payment amount of \$7,500.
- Districts must have the participant complete a W-9.

- Required claim backup documentation for all drought practices is as follows:
  - Notarized OSF-3 Form
  - Calculation Sheet (use the current form)
  - Self-Certification Form
  - Any relevant receipts and In-Kind contributions
  - Landowner Consent Form, if required (use the current form)

### **1.6 Requests from Public for Emergency Drought Cost-Share Records**

- Requests must be in writing to the district.
- Provide only what is requested. For example: if they just want to see the ranking sheet(s) then share only the ranking sheet(s).
- Districts are not required to create a new record to respond to a request.
- Do not include SSN.
- You can include name, address, phone number, email address

## **Rehabilitation and Repair Projects:**

- **Upper Black Bear Creek Site 62** – The City of Perry has been clearing land rights and is working to finalize the condemnation paperwork and payment on the Vann property. The final commissioner’s award has been submitted to the City and the City of Perry is moving forward to complete the required ADS-78 form and attorney letter clarifying that all land rights have been acquired by the end of November, thus allowing the rehabilitation to move forward to contracting.
- **Sallisaw Creek Site 33** – A hearing was held on April 4 at 10 am. The judge failed to issue his order within 60 days. The District is looking at filing a Writ of Mandamus with the appellate court in the OWRB case challenging the hazard classification of the dam. The OWRB case needs to be finalized before pushing hard on the pending condemnation case for the rehab.
- **Lower Bayou 12** - Working to set a date to meet with the main landowner; have received a map of the easements acquired and working to finalize all remaining areas that need easements.

## ***Other Flood Control Issues:***

- **Bear-Fall Coon Creek Site 20** – Red-marked pages of agreement between the district and the landowner were sent to the Defendant’s attorney and the defense attorney sent back comments. A call is being set to review the comments and adjust the agreement.
- **Little Wewoka Creek Site 1** –Held a meeting with the Muscogee Creek Nation and the landowners around this structure to discuss land rights and the acquisition of a lease. Have sent follow-up emails to the Nation and awaiting a response.
- **Quapaw Creek Site 23** – Received a demand letter from landowner regarding building below the dam. The letter was referred to the D.A.’s office for a response. The response was sent out on August 25, 2022 to the landowner. The ADA has had no response back from the landowner and the Lincoln County CD has seen no additional construction on the property.
- **Upper Black Bear Creek Site 73** – Landowner placed a house pad below the dam and the district is working on a violation letter.

- **Upper Elk Creek Site 23D** – Landowner has built a small dam in the flood pool of this recently rehabilitated site. District working on a letter to landowner detailing out the problems with the small dam.

**Illinois River Riparian Easement Program**

- Annual agreement payments have been made by the three conservation districts covering the area for the **Illinois River Riparian Easement Program**. These agreements are for the lease offset for riparian exclusion and non-use/disturbance of riparian corridor areas. The total participation and payout for 2022 includes 24 landowners covering 1,195.9 riparian acres for a total payout of \$72,959.40. The following is a summary of acreage and payment by conservation district and continued exclusion.






A board of five conservation district directors (three elected and two appointed) governs the conservation district.

The district has cooperator agreements with 1,010 producers in the county.

The board of directors submits this annual report to inform the public of this past year's conservation accomplishments.

We invite all citizens to become familiar with the activities of the Kiowa County Conservation District and to visit our office and get acquainted with our staff.

We also invite people to attend our monthly board meeting held on the second Wednesday of each month at 9:00 A.M.





The NRCS provides technical assistance to the conservation district and district cooperators, and administers several USDA technical and cost share programs.

## *Providing Equipment and Services to Producers in the District*

The Kiowa County Conservation District rents conservation equipment to producers including a grass drill, No Till Drill, and an Aerator. The district also owns a Skidster which the District Manager takes to sites to cut trees. The district also sells custom blend grass seed..

## *Oklahoma Conservation Cost Share Program*

The conservation district administers the Oklahoma Conservation Cost Share Program for Kiowa County. This past year the district has worked with PY23 contracts and PY24 obligating funds and contracts for the program year. Contracted amounts for PY23 were 16,000.00. All but one participant completed their contracts. PY24 obligated funds are 30,300.00. A request was sent for more money.

The Oklahoma Legislature established the program in 1998. It is an annual program requiring funding from the legislature.

The conservation district board obtains input from citizens to determine which conservation practices will be included in the program each year.

## *Watershed Program*

There are seven watershed projects in Kiowa County. Watershed sites includes Oak Creek with six sites, Cowden Laterals with five sites, Gyp Creek with one site, Rainey Mountain with twenty nine sites, Saddle Mountain with eleven sites, Upper Elk Creek with three sites and Otter Creek with 4 sites. The Kiowa County Conservation District is a sponsor for these projects. Kiowa County shares operation and maintenance responsibilities with the Washita County Conservation District for the watershed dams physically located in Washita County but taken care of by Kiowa County Watershed Aide.

The conservation district makes annual inspections of these flood control dams and provided maintenance work on the dams including, clearing trees from the dam and earthen spillway on 9 sites, repairing erosion problems and cattle trails on 14 sites, cleared crossing on 1 site, mowed 3 sites, sprayed trees on 9 sites, mulched trees on 1 sites, cut and piled trees on 2 sites checked problem with Charlie Colvin, NRCS on 3 sites, and checked numerous sites after different rain events. tore out corners and parts of fence on 1 sites, replaced corners and repaired gate on 1 site, Kiowa County Watershed County Watershed Aide also assisted Washita County CD, Dewey County CD, Grady County CD, Logan County CD, and Custer County CD.

## USDA Conservation Programs

The conservation district works closely with the NRCS in carrying out conservation work in the county. The NRCS staff provides technical assistance to the conservation district and to county land users. The NRCS also administers several federal cost share programs.

Listed below are accomplishments through federal conservation programs in FY21.

- ❖ Twenty four Environmental Quality Incentives Program (EQIP) contracts were developed for a total of \$719,460.00 in cost-share assistance.
- ❖ One Conservation Stewardship Program (CSP) was approved for \$45,454.00.
- ❖ Nine Conservation Stewardship Program Grasslands Conservation Initiative (CSP-GCI) contracts were approved for \$58,470.00.
- ❖ One Environmental Quality Incentives Program (EQIP CIC) contract was approved for \$45,529.00.

## NACD GRANT ACCEPTED AND ADMINISTERED

The Kiowa County Conservation accepted a grant offer to have the ability to hire a new employee. The new employee was hired and began work April 1, 2021. This employee continues to work under the grant program at this time. This employee has been a great asset to the NRCS and District.

## **NETWORKING AND MEETING**

The Kiowa County Conservation District Directors and employees attend the OACD State Meeting in Oklahoma City from February 27 to March 1, 2022. This was the first in person OACD State Meeting since covid began.

Covid protocol kept some networking and meetings from taking place. OACDE teleconferences were used to keep in touch with other districts. Zoom meetings were held for outreach and other meetings.

## **LONG RANGE PLAN PROGRESS**
