CONSERVATION PARTNERSHIP REPORTS

USDA-Natural Resources Conservation Service: Kristina (Tina) Jerome, NRCS, reported on staffing and the appointment of Brooke Taylor as Acting Assistant State Conservationist for Outreach while Gilbert Guerro is on detail. Ms. Jerome noted resignations of staff members. Ms. Jerome also mentioned their meeting in Tulsa for AISES (American Indian Science and Engineering Society) was also a great benefit for recruitment. There will be a meeting for the State Tech Committee Meeting on May 18, 2023, and an IRA funding discussion in both Virtual and inperson meeting.

Oklahoma Association of Conservation Districts: Joe Caughlin, OACD, thanked the Commission and Trey Lam for organizing and being a part of the NACD Legislative Washington Fly-In. He also mentioned Conservation Day at the Capitol in April with good participation from the districts. Larry Wright wanted to thank the Commission staff for assistance with the Land and Range Judging contest that has 38 states represented and 188 teams registered.

OKLAHOMA CONSERVATION COMMISSION STAFF

Executive Director: Trey Lam, mentioned the significance of the size of the event for the Land & Range Judging. He was impressed with the many teams and members that showed up and mentioned it is a great opportunity for students to begin their career path. He mentioned Conservation Day at the Capitol where districts were successful in meeting with their representatives and were able to witness the passage of the North Canadian Red Cedar Bill 2239. Legislative session is in full swing and funding for conservation is looking strong. A new hire this month Jake Searock, OCC/NRCS Public Information Officer.

Water Quality Program: Shanon Phillips, OCC Water Quality Division Director, Ms. Phillips stated the report is in the packet, with a copy of the article from the Yard-by-Yard program. She mentioned there were 30 landowners that reached out to for soil health consultations. The Soil Health and Blue Thumb presented at 36 Conservation District sponsored natural resource days. The Commissioners directed a question for Greg Kloxin, Soil Health Director, about the Soil Health Cost-Share Program, in which he responded is in process.

Office of Geographic Information and Technical Services: Mike Sharp, Director, Dr. Sharp stated that there was a report in the packet, and that he would be happy to answer any questions. He discussed the potential for funding to get Lidar mapping updated for portions of the state.

Abandoned Mine Lands Reclamation: Trampas Tripp, Director. Mr. Tripp stated the report is in the packet and he would be happy to answer any questions. He mentioned one unpaved roads pilot project was completed and 2 are near completion in Lincoln County. He also noted that three applicants were interviewed for additional Nutrient Management Planning position.

District Services: Clancy Green, District Service Director, Ms. Green introduced Tammy

Curry, Area II District Coordinator. She mentioned the report is in the packet.

Conservation Programs: Tammy Sawatzky, Director. Ms. Sawatzky mentioned Wendie Sharp has moved to full time and will be focusing on digitizing watershed easements. She also mentioned Taylor Marshall conducted an in-person training for staff in and around Wagoner, OK and held a TEAMS meeting for the districts as a refresher on cost share program, ensuring it is not the same as the emergency cost share program.

Assistant Director: Lisa Knauf Owen. Ms. Owen reported Jeannie Parsley did an amazing job keeping up with the claims and thanked her for her time and effort while we had an accounting vacancy. There were \$2 million drought claims and \$5 million in district claims throughout the month of April. She mentioned the additional vehicle purchase request, which is in process. She noted that Scotty Herriman's last Commission meeting will be in June and a luncheon is being planned in the Agriculture building Atrium after the June Commission Meeting. She also announced that the new Area III commissioner has been confirmed by Senate Committee. Grant Victor from Ottawa County Conservation District will begin serving effective July, 2023.

Love County Conservation District

The Love County Conservation District is a local subdivision of state government. The district was formed in 1939 to ensure local people are involved in conservation activities.

The function of the district is to make available technical, financial and education resources and coordinate them so that they meet the needs of the local community with respect to conservation of soil, water, and related natural resources.

A board of five conservation district directors (three elected and two appointed) governs the conservation district.

The board of directors submits this annual report to inform the public of this past year's conservation accomplishments.

We invite all citizens to become familiar with the activities of the Love County Conservation District and to visit our office and get acquainted with our staff. We also invite people to attend our monthly board meeting held on the first Tuesday of each month at 9:00 A.M.

Mission Statement: To provide leadership in a partnership effort to help people conserve, improve and sustain out natural resources and environment.

The Conservation District office is located at 1215 N. Highway 77 in Marietta Oklahoma, and it shares office space with the Natural Resources Conservation Service. NRCS, a federal agency, provides technical assistance to the conservation district and cooperators and administers several USDA technical and cost-share programs.


Conservation Cost-Share Program



The Oklahoma Legislature established the Conservation Cost-share Program in 1988. It is an annual program that requires funding from the legislature. The Love County Conservation District administers the cost-share program for Love County. The district board gathers input from local producers as to which conservation practices will be offered through the program. Brush management (Cedar), ponds, wells and grass planting have been some of the most requested practices that are approved by the board.

Watershed Program

The Love County Conservation District is the sponsor for the 15 watershed dams in the county. The goal of the district's watershed program is making sure the watershed dams function as they were designed and remain safe. The Conservation district works with their partners and landowners in making annual inspections of these flood control dams and providing maintenance work on the dams including clearing trees from the dam and earthen spillway, beaver control, repairing erosion problems, maintaining good stands of grass on the dams and earthen spillways, and keeping the inlet tower of the principal spillway cleared of debris. Love County has 4 high hazard watershed dams. Changes in downstream land use such as a housing development can cause a hazard classification to change from low or significant to high. A high hazard classification means should there be a dam failure, loss of life could occur. Rehabilitation assessments are completed by NRCS on newly reclassified high hazard dams to determine the need for rehabilitation. Love County recently had watershed Site #3 rehabilitated for brush which had grown up on and around the dam. The dots on the map below indicate the locations of the watershed dams. The red dot indicates high hazard dams.

The Love County Conservation District participates in conservation Education activities. The District Hosts the annual poster contest for kids from local county schools.


The Love County Conservation District also assisted with the Natural Resource Day in Murry County for grade schoolers in and around Murray County, where there were a variety of educational activities for the students.


