The Oklahoma Conservation Commission met Thursday, September 7, 2023, in the Agriculture Building located at 2800 N. Lincoln Blvd in Oklahoma. The meeting was called to order at 9:30 a.m. by Chair Clay Forst. He stated this was a scheduled regular meeting held in accordance with the Open Meeting Law, Title 25, Oklahoma Statutes, Sections 301 and following as amended. ## **CLAIMS/FINANCIAL STATEMENT**

Commissioners reviewed the claims register, p-card statement, revenue summary and allotment budget / available cash report as provided by Ms. Parsley in Exhibit #1. Ms. Parsley stated there was a total of \$3.5 million paid in total claims and payroll for the time period. ## **CONSERVATION PARTNERSHIP REPORTS**

*Oklahoma Department of Agriculture, Food, and Forestry:* JanLee, reported that Secretary Arthur will be visiting Wyoming for NASDA. She stated that Secretary Arthur is the incoming President of the organization. She mentioned ODAFF will be hosting the NASDA annual meeting in Indianapolis, IN next year. Ms. Rowlett also mentioned that ODAFF fire fighters had returned from working Montana wildfires and now have been deployed to southeast Oklahoma to work wildfires. Ms. Rowlett noted that the market development team will have the Made in Oklahoma Store at the State Fair.

*USDA-Natural Resources Conservation Service:* Jeanne Hamilton, reported that the NRCS fiscal year is coming to an end and staff are working to complete reports. NRCS has funded 880 contracts and obligated \$264,000 for EQIP and 270 contracts, obligating \$240,000 for the CSP program. NRCS is working to streamline RCPP processes. There is a national training that will be held in November. Ms. Hamilton stated there are new hires, Tiffany Nelson as RCPP Coordinator and Diana Perry as State Engineer. The State Tech Committee Meeting will be held in mid-October.

*Oklahoma Association of Conservation Districts:* Sarah Blaney, Executive Director, reviewed the area meeting schedule and noted that the agenda is taking shape. She reported OACD has received \$250,000 from General Mills to purchase no till drills. She stated they will be hiring a youth coordinator position and grants manager position in the near future. OACD is hosting the film screening "To Which We Belong," tonight with the goal of connecting urban and rural producers.

## **STATUS REPORTS**

### **OKLAHOMA CONSERVATION COMMISSION MEMBERS**

Mr. Forst- stated his area did not get any rain and it has been quite dry and thsy lightening has set fires.

Mr. Priess -stated his area received over 9 inches of rain, crab grass for hay and the next cut was being prepare. He stated the drought isn't over yet.

Mr. Crawley-stated its starting to get dry, hoping for more moisture next week. Wrapping up hay bales, many bales this year so far. Ready for the fall.

Mr. Herald- stated the rains have stopped and it is getting dry in those areas. Concerned over the large amount of forage dying back and creating a fire hazard.

Mr. Victor- stated the good rain, grass and getting more soybeans. The droughts not over and the hay and grass are better. September will be a tough month.

## **OKLAHOMA CONSERVATION COMMISSION STAFF**

*Assistant Director:* Lisa Knauf Owen reported on the Drought Commission meeting where OCC was tasked to gather data and input from the districts. Each district has been asked to submit responses to questions and state concerns by September 18, 2023. The Drought Commission will likely meet the 3<sup>rd</sup> week of September to discuss the release of \$17 million that could provide funding to unfunded applicants. Ms. Owen also reported on upcoming Legislative Interim Studies. The first being held on September 18, 2023, to discuss woody invasive species on state lands. The deadline for the FY25 budget request is October 1, 2023.

*Water Quality Program:* Shanon Phillips, OCC Water Quality Division Director, Ms. Phillips stated the report is in the packet. She mentioned the Illinois River Riparian Easement, the program is a long-term lease agreement restricting the use of riparian corridors along the stream's watershed, and to cover the gaps in the riparian area. She stated the soil health team visited 26 producers for consultation. She also mentioned the site visit with Neighbors helping Neighbors.

*Office of Geographic Information and Technical Services:* Mike Sharp, Director, Dr. Sharp wanted to announce there will be a solar eclipse in April 2024 in southeast Oklahoma. He is working with Office of Emergency Management to assist with mapping needs for the event. He stated that there was a report in the packet, and that he would be happy to answer any questions.

*Land Management:* Trampas Tripp, Director. Mr. Tripp mentioned they were conducting interviews for the Division APO position. He stated the completion of the unpaved roads training in Weatherford on August 10, 2023, with a total of 40 in attendance and 6 county commissioners were ready to submit projects. He mentioned the completion of projects in Lincoln County. Mr. Tripp reported that the vacancy announcement for Cedar Eradication technicians has been publicized and to date have received 6 applicants. He attended Dewey County Soil Health Field Day to talk about the cedar program. He stated the new vehicles arrived and are ready to be delivered out to the field which will allow planners to increase the number of field visits. Mr. Tripp indicated that rules for the land management division are in the development process and will be ready for approval and to be published by November 15, 2023. He stated the report is in the packet and he would be happy to answer any questions.

*District Services:* Clancy Green, District Service Director, Ms. Green reported that this year conservation districts will be required to file IRS Forms 1099 in the IRIS System, which will all be electronic. She noted that she and the Area Coordinators are preparing for Area Meetings. She mentioned the hiring and current vacant positions in conservation districts and that the District Services APO, Alicia Ryan, had resigned and the Commission will be advertising the vacancy soon. She mentioned the report is in the packet and would be happy to answer any questions.

*Conservation Programs:* Tammy Sawatzky, Director. Ms. Sawatzky stated that after many months of delay and backorder the division has received 5 new trucks that are being deployed to the field. She and staff attended the pre-construction meeting for the Watershed Shop in Chickasha on August 10, 2023, and the emergency drought commission meeting on August 23, 2023. Participated in a meeting with Stillwater and NRCS about the potential for mitigation with Lake McMurtry and Perry Lake Rehab. She stated the report is in the packet and she would be happy to answer any questions.



**Illinois River Riparian Easement Report**

Water Quality Division, Oklahoma Conservation Commission  
*Report for Brooks Trammell*

***Purpose and Scope of Program***

- Long-term lease agreements restrict the use of riparian corridors along streams in the Illinois River Watershed. This program was intended to supplement the Conservation Reserve Enhancement Program (CREP) by covering gaps in riparian areas not covered by the rigid qualifications in CREP and therefore allowing landowners the opportunity to enroll contiguous reaches to effectively manage property by whole corridor riparian exclusion.

***Routine Programmatic Responsibilities***

- Programmatic administration and tracking: Enrolled contracts and properties are reviewed, and participants paid annually if meeting contract requirements. District and NRCS staff in the Adair, Cherokee, and Delaware County Conservation Districts are integral to this program and help complete most activities.

***Annual Status:***

- Currently, twenty-one (20) contracts/properties have been reviewed and payment made or are in process for annual payments, totaling 1,093 acres of exclusion, with an expected payout of \$66,601.50.
- Adair County accounts for most of the contracts, with seventeen (17) participants, covering 801.5 acres, with an expected payout of \$48,090. Most reviews are complete, with some agreements paid while some are in process.
- Cherokee County has two (2) current contracts, covering 242.5 acres, both of which have been reviewed and payments made totaling \$15,277.50.
- Delaware County has one (1) remaining contract of 49 acres, which has been reviewed with a payment made of \$3,234.00.

- Wetland Determinations: Review potential impacts to wetlands and aquatic resources from publicly funded project
- Mitigation Plan Review: Review documents for *In-Lieu-Fee* and Mitigation Banks as a member of the Oklahoma Interagency Review Team (IRT)
- Respond to Citizen Requests: Deliver wetland information to the public, primarily in response to requests through the Wetland Registry hosted on the Wetlands Program Website

### ***Active Grant Projects:***

- Floodplain Mapping Project: This project is funded by a US Environmental Protection Agency (USEPA) 104(b)(3) Wetland Program Development Grant (WPDG) to update National Wetlands Inventory (NWI) maps along the Arkansas River between Keystone and the Salt Plains, as well as the Canadian River between Eufaula and Canton.
- Oklahoma Rapid Assessment Method (OKRAM) Integration: This project is funded by a WPDG to refine development of OKRAM, a condition based assessment tool for wetlands. Project highlights include (1) collection of an additional 30 OKRAM assessments at wetland types under-represented in our dataset, (2) compilation of 300+ OKRAM assessments into a database and publicly available web application, and (3) analysis of dataset to refine method.
- Restorable Wetlands Identification Protocol (RWIP): This project is funded by a WPDG to continue to develop and refine a desktop screening tool that can be used to identify wetland restoration opportunities. Project highlights include (1) remapping of restorable polygons using higher resolution datasets in 30 watersheds, (2) attributing restorable polygons with restoration feasibility resulting from hydrologic modification in 30 watersheds, and (3) data sharing through a web application.
- OKRAM Guidebook: This project is funded by a WPDG to develop guidance materials for OKRAM, to help promote usage of the method. Project highlights include (1) a detailed OKRAM guidebook, (2) digital training materials and an in-person training delivered in 2024, and (3) coordination with the United States Army Corps of Engineers (USACE) to help promote usage of OKRAM in CWA programs.
- National Wetlands Condition Assessment (NWCA) Intensification: NWCA is a component of the National Aquatic Resource Survey (NARS) conducted every 5 years. OCC is the lead contractor for data collection in Oklahoma. NWCA is funded by Clean Water Act 106 money. The most recent NWCA was completed in 2021, with a state intensification to enhance sample size to 50 wetlands in 2022. OCC will analyze data and summarize findings on the condition of Oklahoma wetlands in a report in 2023.
