#### **Organization of the XYZ Conservation District**

A political subdivision of the State of Oklahoma – authorities, powers and structure contained in O.S. Title 27A. Established in 2020, the BASSY Conservation District was created to ensure the state of Oklahoma would continue to provide the means for future success of the Bigfoot Abominable Snowman Sasquatch Yeti population of our area.

This district serves the area within the boundaries of the state of Oklahoma, approximately 44,774,400 acres.

#### General Nature & Natural Resources of the District:

The state is a patchwork of plains, hills, and mountains and, moreover, is drained by two great river systems, the Arkansas and the Red. The Arkansas, born in the Colorado Rockies, enters Oklahoma in the north, gathering the Salt Fork, Chickaskia, Cimarron, Verdigris, Grand, and Illinois rivers. Human ignorance - Lack of knowledge and general unwillingness to learn results in a lack of availability of educated persons to carry out the mission and vision of the district.

Insufficient living accommodations and nutrition sources - Due to migration and increased population, adequate food and shelter are not as abundant as needed.

Technological advancements - Surveillance mode improvements & AI pose a threat to safety and quality of life.

Global warming - sudden weather variances and extreme environmental changes are difficult for the BASSY population to withstand.

 Endangered/ species - As our world evolves and continues consumption of land and water resources, the species will face threats and the possibility of extinction
