Ms. Owen presented 64 amended agreements in preparation for the new fiscal year. She requested the approval of the following amended agreements on Exhibit #2, items "e-ppp." After discussion, a motion was made by Mr. Victor and seconded by Mr. Crawley to approve the amended agreements as presented. Those voting aye were: Forst, Herald, Priess, Crawley and Victor. Nay votes: none. Motion carried.

CONSERVATION DISTRICT DIRECTOR APPOINTMENTS

Ms. Green discussed with Commissioners recommendation of Conservation District Director Appointments (Exhibit #3). After discussion, a motion was made by Mr. Priess and seconded by Mr. Herald to approve the district director appointments as presented. Those voting aye were: Forst, Herald, Priess, Crawley and Victor. Nay votes: none. Motion carried.

DECLARING CANDIDATES AS ELECTED WHERE ONLY ONE PERSON FILED

Ms. Green discussed with Commissioners possible approval to declare the candidates in districts where only one eligible person filed a Notification of Declaration of Candidacy as elected to Position #2 (Exhibit #4). After discussion, a motion was made by Mr. Herald and seconded by Mr. Crawley to declare the candidates elected in districts where only one individual filed. Those voting aye were: Forst, Herald, Priess, Crawley and Victor. Nay votes: none. Motion carried.

DECLARING ELECTED DIRECTOR POSTION #2 VACANT WHERE NO ONE FILED

Ms. Green discussed with Commissioners possible approval to declare Position #2 vacant in conservation districts where no one filed for election (Exhibit #5). Ms. Green made the recommendation to declare the position vacant. After discussion, a motion was made by Mr. Priess and seconded by Mr. Herald to declare position 2 vacant in districts where no one filed. Those voting aye were: Forst, Herald, Priess, Crawley and Victor. Nay votes: none. Motion carried.

REVIEW OF CONSERVATION DISTRICTS ELECTIONS

Ms. Green discussed the review of Conservation District Elections where more than one candidate filed for position 2 (Exhibit #6). No vote or action required.

CONSERVATION DISTRICT LONG RANGE PLANS

Ms. Green stated the drafts for the long-range plans will be presented to the Commissioners in July for approval. She stated there are 81 submitted to date and is awaiting plans from Alfalfa, McClain, and Osage Counties for submittals.

OUT OF STATE TRAVEL REQUESTS

Mr. Lam requested the approval for out of state travel (Exhibit #7), item "a-b." After discussion, a motion was made by Mr. Victor and seconded by Mr. Herald to approve the travel request as presented. Those voting aye were: Forst, Herald, Priess, Crawley and Victor. Nay votes: none. Motion carried.

CO-SPONSORSHIP OF A MEETING

Mr. Lam requested the ratification of co-sponsorship of a Soil Health Event that was held in Weatherford, Oklahoma (Exhibit #8). After discussion, a motion was made by Mr. Herald and seconded by Mr. Crawley to ratify the meeting co-sponsorship as presented. Those voting aye were: Forst, Herald, Priess, Crawley and Victor. Nay votes: none. Motion carried.

COMMISSION FY2025 APPROPRIATION AND BUDGET

Mr. Lam reviewed the Commission's FY25 appropriation as outlined in Exhibit #9. He stated that the session went livestream and the budgets discussions were transparent and more public. The employee salary adjustment for the agency and districts are part of the appropriation and will be implemented July 1st. Budget planning meetings for each division will be held in the next two weeks. The unpaved roads program received \$1,125,000 for 15 more projects, \$1,000,000 for expansion of the cedar project, and \$1,5000,000 for the Aerial Photography. The FY25 appropriation for the agency will be \$30,995,469. No action needed.

No new business

CONSERVATION PARTNERSHIP REPORTS

Oklahoma Department of Agriculture, Food, and Forestry: JanLee Rowlett mentioned that after the session concluded their budget meetings will begin with their Division Director. Secretary Blayne Arthur will continue as Chair of NASDA and begin travel to other states during the summer. The Board of Agriculture meeting is scheduled for Wednesday, June 5, 2024. Ms. Rowlett introduced the new intern, Sarah Mullins.

USDA-Natural Resources Conservation Service (NRCS): Jeanne Hamilton reported the Chief's visit was delayed and would be rescheduled for later in the year. The space that was being considered for the Love County employees following the tornado did not work out and staff has been relocated to Ardmore temporarily. The new building will break ground this week in Marietta. NRCS has had 5 employees that had left with 2 retired, 2 moving to other agencies and 1 resigned. She mentioned NRCS now has Direct Hire Authority from OGC, but NRCS at the national level

has not provided states with guidance or numbers on proceeding with those hires yet. NRCS is still evaluating the structure and 20 people will be meeting to talk through the input received from partners and staff across the state. On June 18, 2024, there will be a State Technical Advisory Committee meeting in Stillwater. She mentioned they are over 95% obligated on EQIP with over \$58 million contracted. In July the National Easement Program Division will be in Oklahoma to help staff understand the process of getting more conservation easements closed. There are 15 students on board for internships and will all meet in Stillwater. She stated they have 2 tribal members onboard to assist with tribal customers across the state. They had an agreement for 4 positions for shared planners, they had received enough funding to add an additional 5th position without no cost amendment.

Oklahoma Association of Conservation Districts (OACD): Sarah Blaney, reported that it was a very positive legislative session. Jean Lam represented OACD and spoke at a Food & Beverage conference in Minneapolis. The National FSA director will be attending the NACD South Central Meeting in Oklahoma. OACD is planning for Climate Smart Commodities Grant. The districts will be selected using NASS data.

STATUS REPORTS

OKLAHOMA CONSERVATION COMMISSION MEMBERS

Mr. Forst – he expressed his appreciation for his service and his honor to serve with the Conservation Commission for 5 years. He mentioned his area was doing well, green grass, ponds full and cattle fed.

Mr. Herald – he stated that his area received 2-3" of rain in the past 2 days.

Mr. Priess – stated there was plenty of moisture and glad to have missed some of the bad storms.

Mr. Victor – stated his area received rain, loss of Bermuda grass was coming back, cutting wheat and bailing hay, and the ponds are full.

Mr. Crawley – stated improved rain, grass, ponds are full.

OKLAHOMA CONSERVATION COMMISSION STAFF

Executive Director: Trey Lam announced the new Area IV Commissioner that was nominated is Joshua Haven, from Upper Washita Conservation District. He indicated that he is a farm loan officer at the local band and a cattle rancher. He mentioned attending the Senator Boozman listening session on the farm bill in Oklahoma City. Mr. Lam attended the unpaved roads training in Lincoln County. A meeting was held with OMES IT, in which Mike Sharp will mention in his report. He was appreciative for Sarah Blaney taking lead on the South-Central meeting. OCC had a full staff meeting on May 29, 2024, with each division and their work details. He visited a ranch near Sulphur where they are using 1,300 goats to help with blackberries and brush.

Water Quality Program: Shanon Phillips, OCC Water Quality Division Director, mentioned the Aquatic Connectivity Team Kickoff Meeting and training, the soil moisture monitoring with the Terry Peach Project for removing Cedar, the SHIP program has been running for 2 months, and the conservation planning training for the state cost share and SHIP Programs. She stated the report is in the packet and she would be happy to answer any questions.

Office of Geographic Information and Technical Services: Director Mike Sharp mentioned the photography funding and working with James Mural, USDA, and the agreement with the NAPS and possible start by December. He stated the report is in the packet and he would be happy to answer any questions.

Land Management: Trampas Tripp, Director. Mr. Tripp reported the unpaved roads training with 44 in attendance in Lincoln County. He mentioned the site showing for reclamation of the Gilbreath Copper Mine with bid of \$1.9 million. The Howerton Tar Creek Project had a prebid meeting on June 5, 2024. He mentioned the \$750,000 budget from OSU continued agreement. Mr. Tripp stated the report is in the packet and he would be happy to answer any questions.

District Services: Clancy Green, District Service Director, Ms. Green reported preparing conservation district allocations that will include the 10% salary adjustment for district employees. This month's district training is scheduled with Oklahoma Public Retirement (OPERS) presenting. Next month's training topic will be district allocations. She mentioned the current vacancies in the report. She stated the report is in the packet and would be happy to answer any questions.

Conservation Programs: Tammy Sawatzky, Director, mentioned the watershed O&M training and claims, reviews with watershed aide annual preparations. A review of plans for the design of the Caston Mountain Site #2 was scheduled for June 6, 2024, and the Upper Black Bear #62 is pending on response with comments from the public. There was a training with Janet Stewart for title attorneys on flood control and easements for landowners. She noted that the deadline for the following emergency drought practices; cover crop, heavy use protection, pasture planting, pasture tap and pond clean out is June 30, 2024. All claims for these practices must be in the Commission office by August 2, 2024. She mentioned the report is in the packet and would be happy to answer any questions.

Assistant Director: Lisa Knauf Owen mentioned a letter of appreciation from the Oklahoma Prescribe Burn Association for the Kubota side by sides provided for use with the local burn associations. She mentioned that she is working with John Weir with OSU to come speak to the Commission about OPBA and the work being done statewide.

RECOGNITION OF CLAY FORST

Mr. Forst was recognized for 5-year service as Area IV Commissioner. Mr. Lam and Ms. Owen thanked him for his service and the example of his ranch, Stuart Ranch, has offered. Mr. Forst thanked the commission for the guidance and the watershed practices.

COMMISSION OFFICERS FOR FISCAL YEAR 2025

Commissioners discussed the rotation of officers for the coming fiscal year. Mr. Dan Herald will be stepping up this year as chair. After discussion, a motion was made by Mr. Priess and seconded by Mr. Crawley to approve the fiscal year 25 slate of officers as Dan Herald, Chair; Robert Priess, Vice Chair; Grant Victor, Secretary. Those voting aye were: Priess, Forst, Victor, Herald and Crawley. Naye votes: none. Motion carried.

PROPOSED EXEVUTIVE SESSION

At 11:00 a.m., a motion was made by Mr. Victor and seconded by Mr. Priess to enter the Executive Session as authorized by the Oklahoma Meeting Act Section 307 (B)(1) of Title 25 of the Oklahoma Statutes, an executive session may be held for the purpose of discussing the employment, hiring, appointment, promotion, demotion, disciplining or resignation of any individual salaried public officer or employee. Those voting aye were; Victor, Priess, Forst, Herald and Crawley. Naye votes: none. Motion Carried. The Commissioners requested that Mr. Lam, Ms. Stewart and Ms. Owen remain in Executive Session.

The Commission entered Executive Session at 11:00 a.m. on Monday, June 3, 2024.

The Chair invited the public back into the room and stated that the Commission returned to open session with all Commissioners present at 11:14 a.m. A motion was made by Mr. Crawley and seconded by Mr. Herald to return to open session. Those voting aye were: Victor, Priess, Forst, Herald, and Crawley.

COMPLIANCE STATEMENT

Clay Forst, Chair, announced that the Commission entered into an executive session at 11:00 a.m. to discuss the salary of the Executive Director as it relates to the state's statute and rules regarding the Agency Director Pay Structure. Those present for the entirety of the executive session were Commissioners Clay Forst, Dan Herald, Grant Victor, Gary Crawley and Robert Priess, as well as agency staff Trey Lam, Lisa Knauf Owen, and Janet Stewart. No action was taken by the Commissioners while in executive session. The Commission returned to open session at 11:14 a.m.

POSSIBLE ACTIONS RELATED TO MATTER DISCUSSED IN EXECUTIVE SESSION

A motion was made by Mr. Priess and seconded by Mr. Victor to set and establish the pay of the Executive Director of the Conservation Commission, a Grade ED9, at \$151,800 annually to become effective July 1, 2024. This established pay is based off the Agency Director Pay Structure formulated by OMES for the Grade ED9 positions. Those voting Aye were: Priess, Forst, Victor, Herald and Crawley. Nave votes: none. Motion carried.

NEXT MEETING

The next regular meeting of the Oklahoma Conservation Commission is scheduled for Monday, July 1, 2024, at the Oklahoma Department of Agriculture Building. 2800 N. Lincoln Blvd., Oklahoma City, Oklahoma at 9:30 a.m.

His leadership has led to the successful organization of two Resource Management Conferences and the implementation of innovative urban conservation programs in Broken Arrow, underscoring his effectiveness and commitment to the district's mission.

All current staff, colleagues, and volunteers view Tom's experience and participation in district activities as exceptional. For that reason, we would like to recommend him for reappointment to the district board for another twoyear term.

Illinois River Riparian Easement Report

Water Quality Division, Oklahoma Conservation Commission

Report for Brooks Tramell

Purpose and Scope of Program

• Long-term lease agreements restrict the use of riparian corridors along streams in the Illinois River Watershed. This program was intended to supplement the Conservation Reserve Enhancement Program (CREP) by covering gaps in riparian areas not covered by the rigid qualifications in CREP and therefore allowing landowners the opportunity to enroll contiguous reaches to effectively manage property by whole corridor riparian exclusion.

Routine Programmatic Responsibilities

 <u>Programmatic administration and tracking</u>: Enrolled contracts and properties are reviewed, and participants paid annually if meeting contract requirements. District and NRCS staff in the Adair, Cherokee, and Delaware County Conservation Districts are integral to this program and help complete most activities.

Annual Status:

- Currently, twenty-one (20) contracts/properties have been reviewed and annual payments made, totaling 1,085.7 acres of exclusion, with a total payout of \$66,163.50.
- Adair County accounts for most of the contracts, with seventeen (16) participants, covering 794.2 acres, with an expected payout of \$47,652. All contracts are under review for annual payment.
- Cherokee County has two (2) current contracts, covering 242.5 acres, both of which are under review for annual payments totaling \$15,277.50.
- Delaware County has one (1) remaining contract of 49 acres, which is under review with an expected payment of \$3,234.00.

- <u>Wetland Determinations:</u> Review potential impacts to wetlands and aquatic resources from publicly funded projects
- <u>Mitigation Plan Review</u>: Review documents for *In-Lieu-Fee* and Mitigation Banks as a member of the Oklahoma Interagency Review Team (IRT)
- <u>Respond to Citizen Requests:</u> Deliver wetland information to the public, primarily in response to requests through the Wetland Registry hosted on the Wetlands Program Website
- <u>Wetland Conservation</u>: Deliver wetland conservation. This effort is a collaboration with the Nature Conservancy (TNC), International Crane Foundation (ICF) and the Playa Lakes Joint Venture (PLJV). The collaborative workgroup is called the Partnership for Oklahoma Wetland Restoration (POWER). Conservation practices will depend on availability of funding from active grants.

Active Grant Projects:

- <u>Floodplain Mapping Project</u>: This project is funded by a US Environmental Protection Agency (USEPA) 104(b)(3) Wetland Program Development Grant (WPDG) to update National Wetlands Inventory (NWI) maps along the Arkansas River between Keystone and the Salt Plains, as well as the Canadian River between Eufaula and Canton.
- Oklahoma Rapid Assessment Method (OKRAM) Integration: This project is funded by a WPDG to refine development of OKRAM, a condition based assessment tool for wetlands. Project highlights include (1) collection of an additional 30 OKRAM assessments at wetland types under-represented in our dataset, (2) compilation of 300+ OKRAM assessments into a database and publicly available web application, and (3) analysis of dataset to refine method.
- <u>Restorable Wetlands Identification Protocol (RWIP):</u> This project is funded by a WPDG to continue to develop and refine a desktop screening tool that can be used to identify wetland restoration opportunities. Project highlights include (1) remapping of restorable polygons using higher resolution datasets in 30 watersheds, (2) attributing restorable polygons with restoration feasibility resulting from hydrologic modification in 30 watersheds, and (3) data sharing through a web application.
- <u>OKRAM Guidebook:</u> This project is funded by a WPDG to develop guidance materials for OKRAM, to help promote usage of the method. Project highlights include (1) a detailed OKRAM guidebook, (2) digital training materials and an in-person training delivered in 2024, and (3) coordination with the United States Army Corps of Engineers (USACE) to help promote usage of OKRAM in CWA programs.
- <u>National Wetlands Condition Assessment (NWCA) Intensification:</u> NWCA is a component of the National Aquatic Resource Survey (NARS) conducted every 5 years. OCC is the lead contractor for data collection in Oklahoma. NWCA is funded by Clean Water Act 106 money. The most recent NWCA was completed in 2021, with a state intensification to enhance sample size to 50 wetlands in 2022. OCC will analyze data and summarize findings on the condition of Oklahoma wetlands in a report in 2023.




Volunteers wrap up Bug-picking


Stream Protection Training for Cities in Purcell





The Comanche County Conservation District sponsors ten (10) watershed site locations. These watersheds were built to have a direct impact on localized flooding in the area. The district completes annual inspections of these 10 locations, and performs maintenance tasks asneeded

The District and NRCS Lawton Field Office perform annual inspections on all 10 sites. We develop an action plan on issues that are found during this inspection and rank them by priority to begin requesting funding. Issues can range from slope damage to cattle trails to invasive tree species growing on the dam or spillways.

District Grass Seed Sales

The Comanche County Conservation District is partnering with local seed vendors to assist producers in getting grass seeds when they need it. This helps lower fuel consumption, delivery fees, and overall costs, thus making it a win/win for all involved!
